#### FLEXIBLE CANCELLATIONS TERMS & CONDITIONS:

These Terms and Conditions, pertaining to the 'Flexible Cancellation' Program, are integrated into the terms and conditions governing your purchase. In the event of any inconsistency between these Terms and Conditions and the terms and conditions of your purchase, the Terms and Conditions of the booking or reservation platform where you made your purchase, or the terms and conditions of the event owner or operator identified on the booking or reservation platform, Tahoe Snowmobiles & Tubing, these Terms and Conditions will take precedence.

#### **DEFINITIONS:**

In these Terms and Conditions:

- "You," "your," and "Customer" denote the individual who acquired a ticket, reservation, or registration for an activity ("activity") from Tahoe Snowmobiles & Tubing to and paid the fee specified by Tahoe Snowmobiles & Tubing to partake in the Flexible Cancellation Program
- "We," "us," and "our" refer to Tahoe Snowmobiles & Tubing.

### FLEXIBLE CANCELLATION OVERVIEW:

By choosing to participate in the Flexible Cancellation Program and paying the associated fee, you are agreeing to the Terms and Conditions below:

- We will provide a limited 'Flexible Cancellation' Fee, as described in these Terms and Conditions, above and beyond our Standard Cancellation Policy for the activity. Our Standard Cancellation Policy typically dictates that all sales are final and nonrefundable at the time of purchase.
- This limited Flexible Cancellation Fee grants you the right to receive a refund of the Net Ticket Price (as defined below) if you are unable or choose not to partake in the Event for any reason, provided that:
  - Your refund request reaches us at least 24 hours prior to the activity Start Time, as set by us.
  - No exclusions specified in these Terms and Conditions apply.

before the Event Start Time will not be eligible for a refund.

# **Coverage and Exclusions:**

The Flexible Cancellation Program exclusively covers the Net Ticket Price you have paid to Tahoe Snowmobiles & Tubing and does not encompass any travel expenses, other costs, or losses incurred by you or any other party, whether related to the activity or not.

To participate in the 'Flexible Cancellation' Program, you must pay a fee for each per-person ticket, reservation, or registration you purchase for the Activity. Enrollment in the 'Flexible Cancellation' Program is not permitted after the date of your purchase of the activity ticket, reservation, or registration unless written permission is granted by us. We retain the right to adjust the Flexible Cancellation Fee at any time without prior notice, although this modification will not affect Customers who have already paid the 'Flexible Cancellation' Fee.

#### **Exclusion for Terrorism:**

No refund will be provided if you opt to cancel your participation in an Event following an act of Terrorism or a threat thereof. "Terrorism" encompasses any activity involving, or preparations for:

- Disrupt any segment of the economy.
- The use or threat of force or violence.
- The commission or threat of a dangerous act.
- The commission or threat of an act interfering with or disrupting an electronic, transportation, communication, information, or mechanical system or any public utility. Where either or both of the following apply:
- 1. Intimidate or coerce a government, civilian population, or any segment thereof

2. Further political, ideological, religious, social, or economic objectives, or express (or express opposition to) a philosophy or ideology.
