We are seeking EOI from Regional and National referees for officiating at this event at the Gold Coast.

- Using 5 courts plus glass court.
- All matches are marker/referee system

Unfortunately there are very few opportunities for Australian referees – “very few” means between 3 and 5. WSF referee requirements for 6 courts is 14 referees, to include:

- WSF-appointed Referees = 6. Our 3 Australian WSF Referees have been appointed, plus 3 from overseas.
- Australian Regional/National Referees = 3
- Additional Referees (non-Australian) = 3
- Extras (Australian) = 2

We invite Member States to nominate one up-and-coming referee to attend for refereeing in early rounds and marking in the later matches of both the Individual and Teams events. We believe we may be able to offer one position for such a referee.

Referees selected are required to attend the National Referees Conference on July 18th.

Referees are required to arrive late 17th July or early 18th July, and leave on 31st July or after the Teams final on 30th if there are appropriate flights.
