- COVID-19 Civic Freedom Tracker launched by ECNL and ICNL that monitors government
  responses to the pandemic that affect civic freedoms and human rights, focusing on
  emergency laws. The tracker is developed with the generous research support from the UN
  Special Rapporteur on the promotion and protection of human rights and fundamental
  freedoms while countering terrorism, Fionnuala D. Ní Aoláin.
- <u>CSO Meter</u> explores and summarizes the emergency measures taken by governments in the
  Eastern Partnership region, their impact on human rights and civic freedoms and how CSOs
  have responded. The CSO Meter will also host a guidance for monitoring emergency
  measures and their compliance with international standards.
- Keep Civic Space Healthy: Saving Lives and Human Rights (in 12 languages): Guidance developed by ECNL in collaboration with ICNL, on what states should consider when adopting emergency measures.
- <u>Civic space in the era of securitised COVID-19 responses</u>: how states have introduced new security-related legislations or used existing measures to further restrict civic freedoms under the cover of fighting the pandemic.
