d. Team Selection (Peter Schwartz)

- i. Eau Claire YMCA
 - 1. All good with their team selections
- ii. Southland
 - 1. Totally fine with their teams and they have seen an increase in the number of players this year
- iii. SAIT
 - 1. Almost everything in in good shape with just a couple issues:
 - a. SAIT has 9 teams but 3 of those teams are in men's 10 (looking to switch one of their level 10 teams with a team that is in level 9 currently)
 - b. Ladies 5 they have enough players to field a team; however a lot of them are spares so they would like one or two more full time players for Ladies 5

iv. University of Calgary

- 1. Conflict with Ladies Level 2:
 - They would like to enter their new team at level 2; however currently they are put into level 3 to avoid bye situations in multiple levels
 - b. One suggestion brought up was to switch spots with one of the two Calgary Winter Club teams that are both in level 2 currently

v. Calgary Winter Club

- 1. Will take away the Ladies level 2 request from University of Calgary
- 2. They will not be losing Gina Schille's level 1 team
- 3. They have team moving up to Ladies level 1 and that team would prefer to stay at level 2 as they don't want to move up

- ii. 0.5 point rule for completing squash officiating course, rules clinic or online officiating course has been adopted needs to be posted to SportyHQ
- iii. Publish the new set of rules and all the team captains should be notified through their Club Representatives
- iv. Division 2 men's ask if they prefer to stay at par 15 or would they prefer to go to par 11 scoring?
 - Peter needs to hear back from all Level 2 teams via Club Representatives by August 28th, 2019 to determine whether or not we will adopt par 11 scoring for Men's Level 2

j. Email Blasts (James Jelinksi)

 - Next AGM invitation needs to go out at least 21 days prior to hosting, which we plan on hosting at our September meeting [Sept. 18th, 2019]
 - 2. September 10th start date for Interclub Pool A and September 17th for Interclub Pool B
 - 3. Address Rule Changes in regards to the officiating clinic and a reminder for all players to review rules prior to the start of the season
 - 4. Mention the officiating clinics, rule clinics and online course

k. Website (James Jelinski, Kyle Mitton and Sean McInnes)

- Ready to go ahead with Henry with SportyHQ as per dialogue at the June meeting
 - 1. Upon signing contract with SportyHQ and paying \$6,000 to SportyHQ they will develop a website and include 4 years of operating costs (which we have paid \$1,500.00 a year for in the past)
 - 2. In order to proceed we would need to provide Henry with content that would be included on the website
 - 3. Henry said that this is very doable and it could be up and running by the beginning of the 2019 / 2020 squash season.
 - 4. We need to pay the \$6,000.00 up front and it is James' recommendation that we move forward.
 - a. Questions and comments:
 - Need to sign contract with SportyHQ that will outline exactly what we get and the maintenance schedule / who incurs the costs
 - ii. Need to provide Henry with all of the content plus any new information that we would want on the site
 - iii. Website will be a standalone website there will be a login on the main website which takes you to SportyHQ as we see it today

iv. To James' knowledge CISA would be responsible for updates and upgrades to the site, needs to be finalized in a contract.

5. Motion for a New Website:

- a. James Jelinski makes motion to develop a contract with SportyHQ to pay them for services to build a website for the CISA at a cost of \$6,000.00. This \$6,000.00 includes our annual usage costs for the next 4 years.
- b. Rick Spyker seconds the motion
- c. Commentary:
 - i. Ron wants to know if there will be a conduit to ClubLocker?
 - ii. We want to ensure that scores and information that is entered in our website is easily transferrable to ClubLocker
 - iii. Recommendation to work with Ken Cross from Squash Alberta as a ClubLocker liaison to ensure formatting is right between the two sites.
 - iv. Kurt Kennedy wants to know how long it is going to take to develop the site and get the information easily transferred over to ClubLocker
 - v. Kyle Mitton is confident that there will be no problems as Squash BC already has a relationship with both parties ClubLocker and SportyHQ
 - vi. Clarification: 4 years of annual fee upfront ($$1,500.00 ext{ x}$ 4 = \$6,000.00) Same cost with added functionality and after the 4 years it they are negotiating to drop our annual usage charge to \$750 annually.
 - vii. Maintenance and updates after it is set up and running is our biggest concern right now what does that look like?

d. Motion carries Unanimous

I. Doubles (From Harvey Huebsch for Jorge Rabacal)

- i. First matches of doubles season to start the second week of September
- ii. Few Changes for doubles interclub this season:
 - 1. Teams will play every week, schedule will be posted on SportyHQ
 - 2. There will only be 2 teams per club per interclub night instead of 3
 - 3. Level 4 doubles will play on Tuesdays (apparently these players do not play singles and it should not impact singles interclub)
 - 4. Level 1, 2 and 3 will continue to play on Thursday evenings
 - 5. Start times for matches will be at 6.00pm and 7.30pm

m. Attendance (Formerly Alan Truong, now Ben Meszaros)

- i. All teams are clear for the upcoming 2019 / 2020 season
- ii. No one missed more than 3 meetings last year Bow Valley was close
- iii. You need to have a Club Representative come to 7 out of 10 meetings
- iv. If you don't have a Club Representative at 7 out of 10 meetings. Your team fees for the following season will double if you cannot meet this requirement.

n. December meeting (Wanda Popadeynetz)

i. Nothing to report until closer to December

o. Squash Alberta (Ken)

- i. 27 registered for the Rules Clinic [August 21st, 2019] at the Calgary Winter Club from 6.00pm to 8.00pm
- ii. 12 to 14 came to the last officiating course which was held at the Glencoe Club on Saturday August 17th from 9.00am to 3.30pm
- iii. Next officiating course comes on September 8th, 2019 at World Health Edgemont from 9.00am to 3.30pm
- iv. They will do more free courses at your club. After speaking to your members at your club get in touch with Ken Cross and they will book the full day course.
 - 1. Maximum 30 people for the course
 - 2. Must provide board room / classroom and squash court at no cost as Squash Alberta is already doing the course for free.
 - 3. They will also do a 2 hour Rules Clinic; these can be more than 30 people but it definitely isn't in depth.
 - 4. Minimum amount of people to run the course would be 12 15 in both cases
- v. Keith Wellon will send the list for anyone who will be grandfathered and receive the 0.5 bonus point 8 Squash Alberta members took the course last year
- vi. Auto Renew of Squash Alberta Memberships
 - 1. Refunded 107 people [moved away, not playing squash this year, would prefer to pay on their own]

- Club Representatives ensure that you talk to members and make sure they understand the insurance benefits of a Squash Alberta membership.
- 3. Insurance is the main driver by having it renewed at July 1st each year
- 4. Website updated to \$25.00 for the one time membership

vii. Ron Questions

- 1. It was mentioned in the last minutes that it was open to abuse, do we know how many cases?
 - a. Approximately 20 people that signed up for student memberships weren't students
- 2. Ron felt it was good tracking mechanism to see student participation not only in Squash Alberta but amongst the three Post-Secondary Clubs [U of C, SAIT and Mount Royal]

• Other Business Arising

- i. Especially now that we are doing the officiating clinics, it is important that all Club Representatives let their Level 1 team captains know that they need to ref and score keep all matches. Currently these players do it for tournaments and premier league and it is a requirement for Calgary Interclub.
- ii. Need to lock down team selection and last changes as soon as possible:
 - 1. Peter will send out another revision as soon as possible
 - 2. Club Representatives responsibility to get back to Peter with conflicts as soon as possible
 - 3. After team selection is complete next steps as follows:
 - a. Send email with the court names and start times
 - b. Send start time requests for any specific teams (early or late)
- iii. James Jelinski to have Alex Altamirano zero out SportyHQ results and get the 2019 / 2020 teams put into SportyHQ
 - 1. Captains to go into SportyHQ and input their Rosters
