1. Being a Certified Facilitator

Being a Certified Facilitator of Access Consciousness is more than “having a job or a license”. As a Certified Facilitator you are **being the tools of Access Consciousness**, meaning that you not only talk about them, you be it.

2. License

ACCESS CONSCIOUSNESS is the owner of certain copyrighted materials related to facilitating classes and workshops worldwide. With this license agreement, Access Consciousness grants the facilitator a license to facilitate classes of Access Consciousness as outlined in this agreement. Subject to the completion of all prerequisites and subject to the Terms and Conditions outlined herein we hereby grant you a limited, personal, non-

exclusive, non-transferable, non-sublicenseable and worldwide license (the “**Certified Facilitator License**”) to conduct Access Consciousness classes, and use Access Consciousness materials and intellectual property as permitted in the Terms and Agreement.

3. Prerequisites

You have to complete all prerequisites updated and listed under

<https://www.accessconsciousness.com/en/facilitators/becoming-a-facilitator/becoming-a-certified-facilitator/>

(the “**Prerequisites**”)

before you schedule or post classes or call yourself a “Certified Facilitator” or “CF”; this applies to posts on your own social media and on the Access Consciousness website.

4. General Terms and Conditions

This contract is based on the official **General Terms and Conditions for Access Consciousness Certified Facilitators** (further referred to as “General Terms and Conditions”). A copy of the current version of the valid and binding Terms and Conditions as of the date of signing is attached to this agreement. The Terms and Conditions will be changed from time to time and will remain part of this contract in the most updated version available. In case of any changes of the Terms and Conditions you will be notified and updated by e-mail, using the e-mail given to us by you in your Access Consciousness profile. The changes made to the Terms and Conditions will be effective by us notifying you. If you do not agree to the changes made, you have to notify us within 14 days of receiving the notification of change. After these 14 days, the new version is binding and automatically changes your license agreement.

5. Type of License

The Facilitator is herewith granted a license as “**Access Consciousness® Certified Facilitator**”, “CF”.

6. Effective Date and Term

This agreement is effective as of the date of signing (a) for 12 months from the date of the facilitator training you attended and qualified you for your license, or (b) until the next qualifying facilitator training at the same time of the year, whatever occurs first.

7. Approved Classes

The Facilitator is entitled to facilitate all the classes as listed in **section 3** of the General Terms and Conditions and create own classes as outlined in **section 4** of the General Terms and Conditions.

8. Selling Classes and Clearing Loops as Products

Selling the recordings of your Classes and Clearing Loops through your shop or otherwise

is considered a “Product”. Creating and selling products is not included in the Certified Facilitator License and requires a separate Product License Agreement as outlined in **section 5** of the General Terms and Conditions.

9. Conditions and Guidelines of Classes

All Conditions, Prerequisites and details regarding the content of all classes authorized to facilitate with the Certified Facilitator License are listed under **section 6** of the General Terms and Conditions

10. License Fee

The Facilitator agrees to pay a **license fee** if applicable, as set out in **section 7** of the General Terms and Conditions.

11. The Renewal Process

If the Facilitator wants to renew the license agreement, the renewal process is listed in **section 8** of the General Terms and Conditions.

12. Termination – Don’t Be a Dick

- 12.1. Access Consciousness has the right to immediately terminate your contract and revoke your license if you violate the Terms and Conditions of this contract and/or violate the principles of Access Consciousness, or in other words: when you are being a dick. The principles of Access Consciousness cannot be finally defined in writing – it is the sum total of “being what you facilitate” and the sum total of all Access Consciousness tools available and updated from time to time in all classes that are available for facilitators.
- 12.2. Being a dick means for example; disempowering people, being a superior asshole, dishonoring Access Consciousness or doing/being anything, which brings Access Consciousness into disrepute. Violence is absolutely unacceptable.
- 12.3. Access Consciousness does not tolerate promotion of multi-level marketing products through Access Consciousness channels. You can do whatever you want as separate business or hobby, but do not promote or mix it with Access Consciousness. Do not abuse your access database to promote your products and do not mix Access Consciousness tools and classes with items or products that are available through multi-level marketing channels only. Do not take advantage of your class participants and NEVER make any product greater than your awareness. Violating the above principle will lead to an immediate termination of your license.

I AM AWARE THAT THIS IS A LICENSE AGREEMENT THAT INCLUDES PAYMENT OBLIGATIONS AND THAT I CANNOT GET A REFUND OF PAID FACILITATOR LICENSE FEES OR CLASS LICENSE FEES IN CASE OF TERMINATION.

General Terms & Conditions for Access Consciousness® Certified Facilitator License Agreement

The following terms and conditions apply to all Access Consciousness Certified License Agreements:

1. Posting and Scheduling of Classes

Your license has to be approved before you schedule or post classes; this applies to posts on your own social media and on the Access Consciousness website.

2. Don't Be A Dick

As a Facilitator you are being the tools of Access Consciousness, meaning that you not only talk about them, you be it. Being a dick means for example; disempowering people, being a superior asshole, dishonoring Access Consciousness or doing/being anything, which brings Access Consciousness into disrepute. Violence is absolutely unacceptable. Access Consciousness reserves the right to decide what being a dick looks like and to terminate your license if you are being a dick.

3. Your CF Classes

- 3.1. Your Certified Facilitator License also includes the Access Bars Facilitator license. Therefore, you can facilitate all classes Bars Facilitators are allowed to facilitate, too.
- 3.2. Furthermore, you are authorized to facilitate ***The Foundation*** and all other classes as they appear in your drop-down menu on the Access website.

- 3.3. Please note that some classes may require you to fulfil additional prerequisites that always have to be completed before facilitating that class.

4. CF Created Classes

Special Classes created by you need prior written approval from Access Consciousness and can only be created in accordance with the guidelines as set out in the CF Commerce Pages located at <https://bfcf.ning.com/facilitator-manual> .

5. Products – Selling your Class Recordings and Clearing Loops

Selling the recordings of your Classes and Clearing Loops through your shop or otherwise is considered a “Product”. In order to be able and authorized to do that, you have to sign a separate license agreement. Creating and selling products is not included in the Certified Facilitator License. Please e-mail customerservice@accessconsciousness.com for our product license agreement.

6. Conditions and Guidelines for All Facilitator Licenses:

- 6.1. Follow all guidelines for your facilitator license in the most up to date version of the Certified Facilitator Manual:
Commerce Pages. <https://bfcf.ning.com/facilitator-manual>.
- 6.2. Adhere to the guidelines for what your license allows you to facilitate and any policies for your license.
- 6.3. Adhere to the requirements for each class you are licensed to facilitate.
- 6.4. Follow the pricing guidelines for the classes you offer, including set prices, country pricing and no discounts on classes with set pricing.
- 6.5. Acknowledge Access Consciousness as the source of the tools you are teaching when you teach any Access classes and events.
- 6.6. Do not behave in a manner that reflects negatively on Access Consciousness.
- 6.7. Acknowledge Gary Douglas and Dr. Dain Heer as the creators of Access. Never imply, directly or indirectly, that it was developed by you.
- 6.8. Do not disempower people.
- 6.9. Do not bully or badmouth class participants, clients or other facilitators.

- 6.10. Do not offer distance Bars, Facelift or Body Process sessions or trades.
- 6.11. Do not share, resell or give away audios, videos, manuals or materials that you received from any Access class you attended.
- 6.12. Be aware of and educate yourself about Data Protection laws and follow the Data Protection guidelines and policies required by Access.
- 6.13. Follow guidelines for marketing your Access business including policies for social media, websites, use of trademarks, using the clearing statement, etc.
- 6.14. Adding any other modality into your Access classes can result in revocation of your license. Do not combine an Access class with any other modality.
- 6.15. Always provide a full refund for any Bars, Facelift or Body Process class or session when asked. Foundation classes can be refunded when the request comes before lunch break of the first day of class for live classes, and at the end of the first segment for online classes.
- 6.16. Submit a monthly acknowledgeizing report via this online form accessconsciousness.com/monthlyreport .
- 6.17. Check in class participants through the Access website within 3 days of the class.
- 6.18. Educate your class participants on what is available to them with Access by going over the end sections of the class manuals.
- 6.19. In your classes use only materials approved by Access Consciousness. This includes only using materials translated by Access; do not do your own translation of Access materials.
- 6.20. Keep your contact information in your Access account up to date. You will be notified of any changes to your license by email using the email listed in your Access account.
- 6.21. As an Access Facilitator, you are on the Access email list. In order to keep your license active, you must receive emails from Access. Please note: If you unsubscribe from Access emails, your license will be terminated.
- 6.22. Creating products using the copyrighted Access tools and materials requires special approval and licensing. Do not create Access products, whether to sell or give away, without written approval.
- 6.23. Do not facilitate classes outside of your license type.

- 6.24. Do not facilitate Golden Planet classes or Demon Classes
- 6.25. Some class topics require special approval beyond the usual approval process, even for intros. Do not facilitate classes or create products on these topics without written approval – 9 Trannies, gaslighting, abuse, sex and beauty.
- 6.26. Only Certified Facilitators can create their own Access classes and products, always subject to prior written approval of Access Consciousness.

7. License Fees:

- 7.1. There is no separate License Fee for your general Certified Facilitator License. It is included in the class price for yearly CF training. The general Certified Facilitator License includes the classes outlined in Section 3. above.
- 7.2. **“CF Created Classes”:** A Class License Fees of 10% applies to classes you as a Certified Facilitator individually create – Certified Facilitators pay 10% class license fees on special classes they create as outlined in the Certified Facilitator Manual: Commerce Pages. Note: the CF must have prior approval before creating special classes.
- 7.3. **Product License Fees** – Certified Facilitators pay 30% product license fees on product sales of Access product they create. Note: the CF must have prior approval and sign a product license agreement before creating products.
- 7.4. **Specialty License Fees** – A Certified Facilitator who meets the prerequisites for becoming licensed as a specialty facilitator pays facilitator and class license fees as outlined in the Access Specialty Facilitator License Agreement.

8. License Renewal Process and License Extension Process

8.1 Renewal Process

- 8.1.1 Facilitate one (1) The Foundation class within the 12 months preceding the Certified Facilitator Training
- 8.1.2 Attend the Global Foundation rewrite class(es) with Gary Douglas and Dr. Dain Heer each year.
- 8.1.3 Attend or purchase the replay of one Choice of Possibilities class within the 12 months preceding the Certified Facilitator Training start date.

Note: For a COP replay purchased from the Access shop, it is the date the class was held, not the date of purchase, that must be within the 12 months.

Note: A COP class can be used only once for renewal. This prerequisite cannot be met using a COP already counted for a previous renewal.

- 8.1.4 Attend one Being You Changing the World class (online or in person) within the 24 months preceding the Certified Facilitator Training start date.
- 8.1.5 Attend the one Certified Facilitator Training each year that is offered by the Access Consciousness Company you got your first Certified Facilitator License with.
- 8.1.6 Complete the Annual Online Questionnaire before the first day of Certified Facilitators Training class.
- 8.1.7 Complete any new Certified Facilitator Training prerequisites.

8.2 Extending Your Certified Facilitator License

- 8.2.1 Your Certified Facilitator license is current from the date of the training class you take until the next training in the same company. Your CF license may be extended, with approval, from the original expiration date to the next CF training class for a 1000 USD fee. You may extend your CF license a maximum of two times and then will be required to attend a training class in person to renew your CF license.
- 8.2.2 Renewal by Video Class—you can renew your CF license by video class one time in your CF career. This must be approved in advance. You must have met all prerequisites for renewing your license, and an additional 30% will be added to your class fee. You cannot renew by video class if you have already extended your license two times in a row.
- 8.2.3 The one-time video renewal and 30% additional class fee may be waived during COVID restrictions for some CF classes.

9. Use of Trademarks

During the term of this Agreement, the Facilitator is authorized to use the trade names, trademarks and service marks of ACCESS CONSCIOUSNESS on a non-

exclusive basis. The Facilitator agrees to use the trademarks as provided and used by ACCESS CONSCIOUSNESS.

10. Access Consciousness is not responsible for your Choices.

What you do as a Facilitator is your choice, not the responsibility of Access Consciousness. You are responsible for your results and what you do as a Facilitator, as an independent contractor. You run your own business and you are fully responsible for every part of it. We do not guarantee any income or profit, nor do we guarantee you any business or revenue. You agree not to hold Access Consciousness liable for any of your choices, and to solely bear the cost of any legal action arising from your actions.

11. Termination - Being a Facilitator is a choice.

- 11.1. If you wish to no longer be a Facilitator, please notify Access Consciousness in writing via the email below (in English) and this agreement can be terminated. Or, if you are not meeting the requirements of being a Facilitator, then Access Consciousness may terminate your License by notifying you in writing, either to the address above or via email.
- 11.2. If Access Consciousness terminates your license for good cause, you are not entitled to any refund of license fees, any previous classes you took or any other expenses you had in connection with this license.

12. You are Running your Own Business

- 12.1. As a Facilitator, you may not act as or on behalf of Access Consciousness without the prior written approval of Access Consciousness. You must make it clear in any materials that you are a Facilitator of Access Consciousness, not the creator of it.
- 12.2. The Facilitator also recognizes and affirms that its services to clients and class participants are provided on an independent contractor basis and at such times and places as Facilitator shall determine at its discretion and that Access Consciousness

assumes no legal responsibility or financial responsibility for any of the activities of the Facilitator.

12.3. The Facilitator shall indemnify and hold harmless Access Consciousness, their officers, managers and members, their demands and causes of action arising from the activities of the Facilitator, including utilizing the Access Consciousness materials and trademarks as provided.

12.4. You, the Facilitator are responsible for payments of any taxes or regulatory fee occurring from your classes.

13. Specific Requirements for Classes

Access Consciousness shall provide specific requirements for the classes mentioned in your contract and reserves the right to alter these requirements including Global Pricing, and using the most updated manual. Access Consciousness will notify the Facilitator if these requirements change and the date they will take effect. These requirements shall form part of this contract.

14. How you can talk to Access Consciousness:

Any communications with Access Consciousness can be made through the emails customerservice@accessconsciousness.com .

15. How we Talk to You:

Communications with the FACILITATOR will be made through the email address given in your Access account. It is the responsibility of the FACILITATOR to notify Access Consciousness if the address changes.

16. Severability

16.1. If any provision of this Agreement is held to be invalid or unenforceable, by any law, rule, order or judgment in any court, such invalidity shall not affect the enforceability of any other provision not held to be invalid.

16.2. If any of these conditions are a problem for you, refer to the 10 Commandments of Access Consciousness, specifically commandments 1 through 10.
