The school will cooperate with the LPHA recommendations and provide all logs in a timely manner.</p> <p>Screening: All students and staff will be screened for symptoms on entry to the school every day, either visually by the staff and/or with confirmation from a parent/caregiver/guardian. Anyone displaying or reporting the primary symptoms of concern will be isolated in the JAT room and sent home as soon as possible.</p> <p>Communication: A letter will be written and sent out via email, text, or phone to communicate with students, families, and staff who have come into close contact with a potential COVID-19 case. The definition of exposure is being within 6 feet of a COVID-19 case for 15 minutes (or longer).</p> <p>Daily student logs: The school will use daily student attendance and sign-in/out records for the purpose of student contact tracing. Parent/guardian names and emergency contact information is stored in the school's Student Information System database. All staff (including substitutes and guest teachers) names and phone numbers who interact with students will be logged daily. 1f. ENTRY AND SCREENING

This can be done visually and/or with confirmation from a parent/caregiver/guardian. Staff members can self-screen and attest to their own health. <ul style="list-style-type: none"> • Anyone displaying or reporting the primary symptoms of concern must be isolated (see section 1i of the <i>Ready Schools, Safe Learners</i> guidance) and sent home as soon as possible. Any person exhibiting a primary symptom of COVID-19 will not be admitted on campus.</p> <p>Students will also be excluded from school for signs of other infectious diseases, per existing school policy and protocols.</p> <ul style="list-style-type: none"> • All students and staff will be screened for symptoms on entry every day. This will be done visually by staff and/or with confirmation from a parent/caregiver/guardian. • Visual screening will take place at the south entrance, inside the first or second door and before children continue to the bathroom to wash hands on their way to the classroom. • When the screening indicates that a student may be symptomatic of COVID-19, the student will be sent home and not admitted to the classroom. If a student is discovered to be symptomatic after being admitted to the classroom, they will be isolated in the JAT room under supervision until a parent/guardian comes to pick them up. • Any staff or volunteer displaying the primary symptoms of concern will go home immediately or be isolated (see section 1i of the RSSL guidance) until someone can take them home. • LPHA advice regarding restriction of students or staff from school who have been exposed to COVID-19 within the preceding 14 calendar days will be followed. • All other LPHA advice regarding restricting students or staff from the school campus will be followed. Parents/guardians can provide information regarding existing conditions that cause coughing. This information will be utilized for the purpose of screening, as previously existing coughs that are not worsening are not considered symptomatic of COVID-19. • Upon each entry to the building at the south door, students and staff and essential visitors will wash hands at a sink. Upon exit through the east door, everyone will use hand sanitizer.
