Statement of Cooperation

The signature above indicates the parties responsible for making regular and punctual tuition payments for each month that the child is enrolled.

If all delinquent payments have not been paid within 30 days, the student may be suspended unless financial arrangements have been made with the school treasurer. Students will be dismissed from school when tuition is more than 60 days in arrears. I understand transcript, records, and report cards cannot be released until all accounts are current. I understand that any legal or collection charges incurred by Adventist Christian Academy to collect unpaid accounts will be passed on to the above signed as part of the unpaid bill.

I understand that I am under contract with the Adventist Christian Academy for tuition for the entire school year unless release is approved by the school board in writing.

We sincerely pledge our loyalty to the aims and ideals of the school, and will bring any and all questions and criticisms directly to the teachers, then administration, so they may be properly considered by those in authority.

I give permission for my child to take part in all school activities, including sports and school-sponsored trips away from the school premises, and absolve the school from liability to me or my child because of any injury to my child at school or during any school activity. If the school is unable to reach me in case of serious illness or accident, I hereby authorize the school to call my physician, and or follow his/her instructions. If it is impossible to contact my physician, the school may make whatever arrangements deemed necessary (see *Treatment Release Form.*)

Adventist Christian Academy and Charleston SDA Church will not be held responsible for charges not covered by student school insurance.

Should any legal action, for any reason, be taken against Adventist Christian Academy, or any employee, or any agent thereof in my child's behalf, and they are found at fault, I agree to pay attorney fees, damages, or other costs that Adventist Christian Academy or its agents should incur to defend itself against such action.

Should any provision of this agreement be declared invalid, then remaining sections and provisions shall remain in full force and effect.

I understand that if my child is transferred from the school, that school records will only be mailed to a new school upon receiving a request. Official records will not be given to the parent.

This school has an open admission policy in regard to gender or race, and no discrimination is permitted against any student by virtue of gender or race. False information may/will result in immediate expulsion and further action may be taken.
