

## Objective

This award recognizes Corporations who are members for outstanding contributions made to a local Chapter and the National Organization in the furtherance of the goals of the chapter and the society, as well as efforts in promoting the professional development of ASMC members.

## Award Criteria

To be nominated a Corporation must have been an ASMC Corporate Member for at least two consecutive years immediately preceding award period. The nominee is the corporation itself, not a member designee of the company. The nominee's contribution must have applicability to the goals of the local chapter and the National organization. Nominees will be scored on contributions of the Corporate Member, scope/impact of those contributions to the local ASMC chapter and the national organization, and any innovative approaches and methods used to further promote the professional development of ASMC and its members. Notable contributions in fostering better understanding of private sector business environment and improvement in the relationship of DoD and private sector through education will be given more weight than just financial support. The performance period for the award is January 1 to December 31. Winner(s) from the previous year cannot be considered in the awards year directly following.

## Submission Requirements

Each chapter may submit one nomination each year; endorsed by the Chapter President, at [asmconline.org](http://asmconline.org)

## Award Selection Procedures

A selection panel of 6, chaired by the Chair of the Corporate Advisory Group (CAG) and assisted by the Awards Committee Chair, will review all nominations and make a final selection. If the Chair of the CAG has a conflict, and the Vice Chair of the CAG does not, the CAG Vice Chair shall preside as Chair of the panel. If both have a conflict, the ASMC Director for Membership will chair the panel.

There shall be no chapter or corporate conflict of interest in judging representation. To the extent reasonably possible, the Awards Committee Chair will replace the recused judge with someone else from the organization. Judges will be as follows:

- Chair of the Corporate Advisory Group (if there is a conflict, another CAG member will be selected)
- Vice Chair of the CAG, (if there is a conflict, another CAG member will be selected)
- Chair of ASMC Awards Committee
- 2 ASMC Chapter Presidents (one from a Category A chapter and the other from a Category A-1 Chapter, provided there is no conflict due to a nomination from their chapter. Should the chapter president initially chosen to judge be involved in a nomination, another chapter president from his/her chapter category will be selected.
- ASMC Director of Membership

Nominators will be notified by May 1 if their nominee has been selected.

## Recognition

Award will be presented at the National ASMC Professional Development Institute (PDI). Winning member may be featured in the *Armed Forces Comptroller* and other ASMC media platforms.

## Deadline

All nominations must be entered by April 10 to be considered. If April 10 falls on a weekend or holiday, the deadline will be the next business day. No exceptions to the deadline will be allowed.
