**Lamar** was employed at Nestle / Stouffers Food Corporation where he worked for 35 years and retired on June 1, 2002.

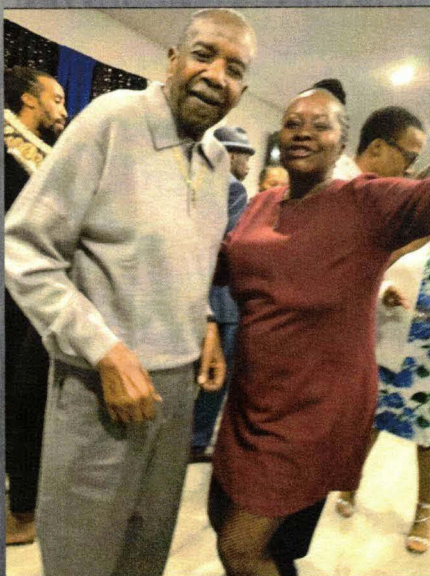
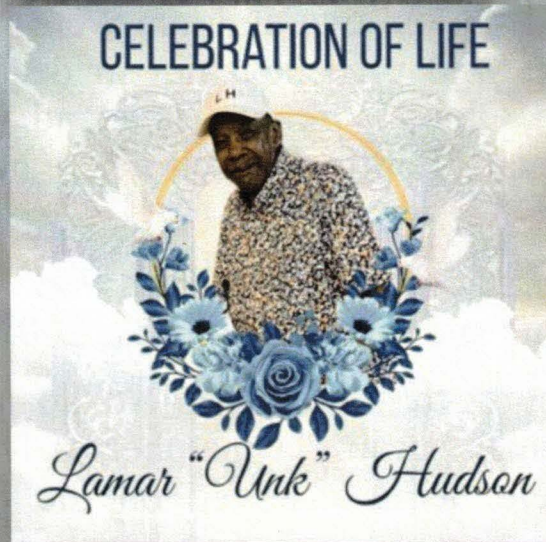
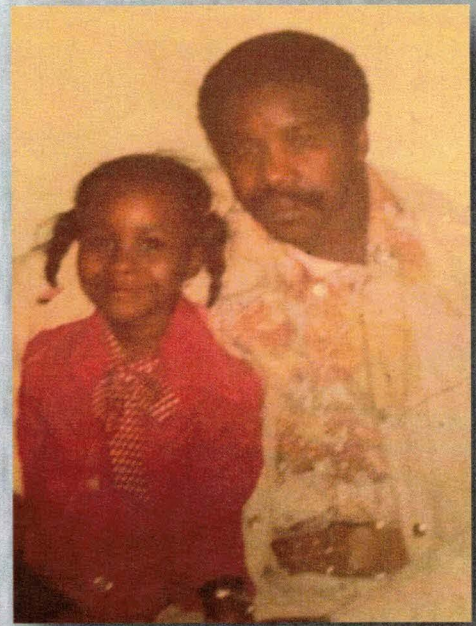
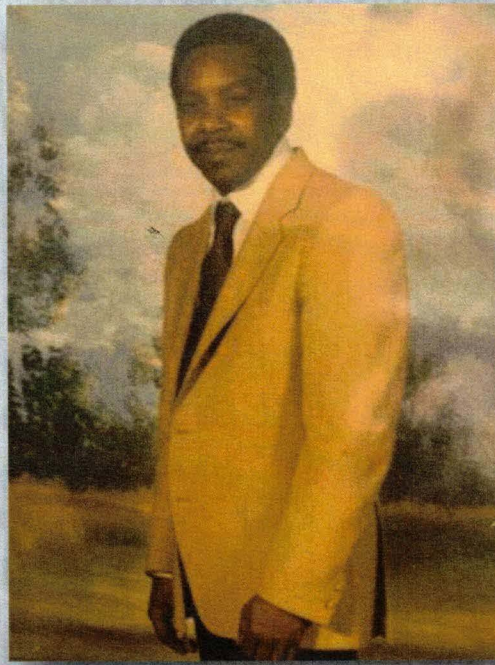
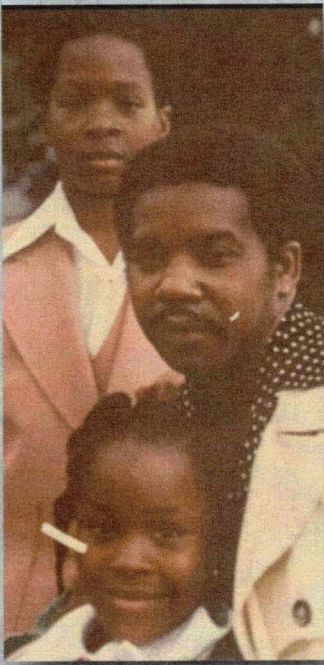

**Lamar** loved being with his family, working in his yard and gardening, fishing, going to the casino "ching ching" as he would call it.

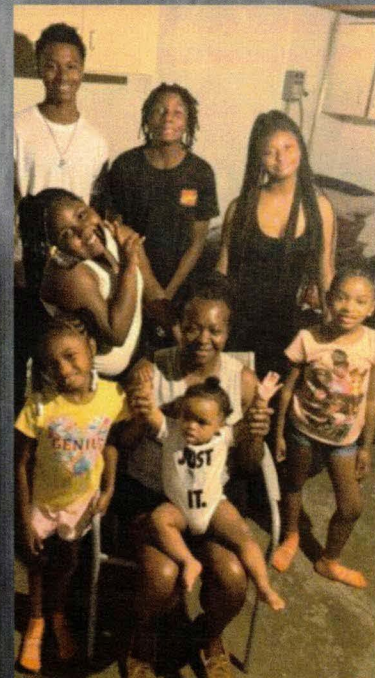
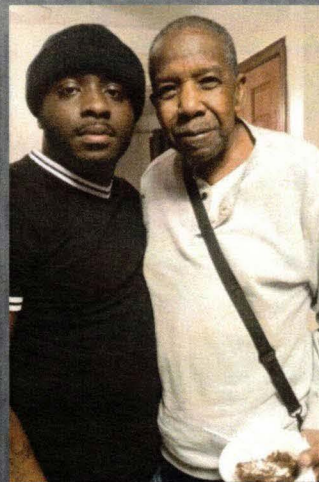
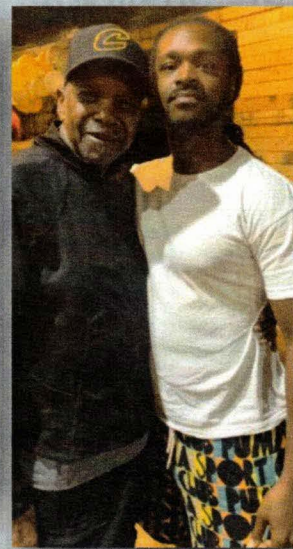
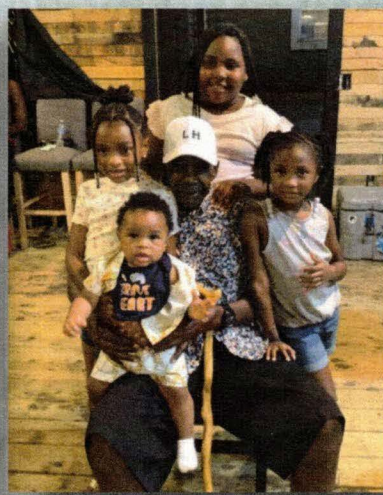

all these things I too will miss*

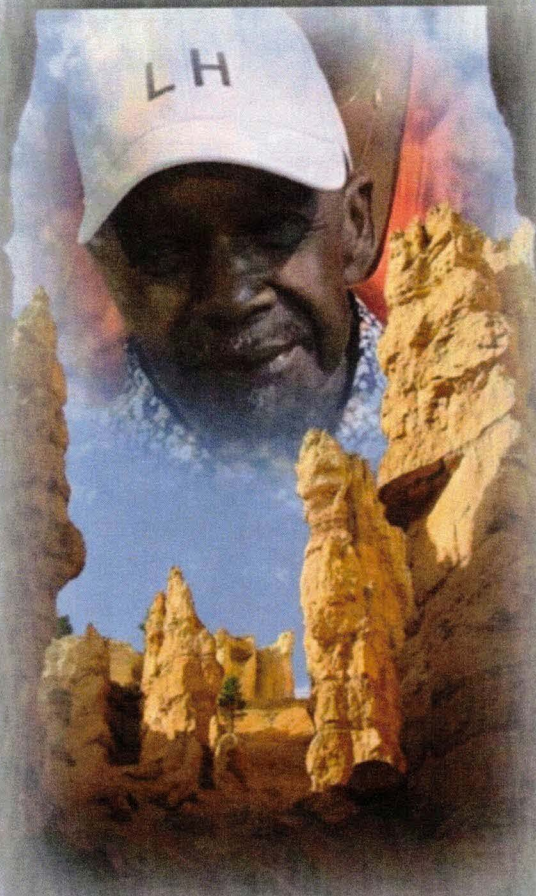
*Be not burdened with times of sorrow
