As a Safety-Care trainer, you are authorized to use and train others in your Organization of Record in the parts of the Safety-Care curriculum in which you have been trained and certified.

Requirements for Maintaining Safety- Care Trainer Certification:

- Complies with Safety-Care standards.
- Trainers are expected to maintain their training skills by spending at least 24 hours teaching Safety-Care during each year of certification. This requirement can be met in the following ways:
 - Teaching initial or recertification classes. Hours spent teaching the core curriculum or advanced modules (including Safety-Care for Families) can be counted.
 - Conducting review sessions with staff who are currently trained and certified in Safety-Care.
 - If the trainer is unable to conduct sufficient training during the year to meet the 24 hour requirement, he or she may alternately participate in a supplemental training session with a certified master trainer. This supplemental training (which is in addition to the regular required recertification) may be completed in person or via video conference.
 - Multiple trainers who teach together can get credit for training hours (up to 3 trainers for 10 or fewer trainees; up to 4 trainers for 11–20 trainees).
- Annual recertification by a certified QBS Safety-Care master trainer.

Any training that you complete as a Trainer, you will continue to complete the Safety-Care Trainee Register and enter all completed information into Trainer Connect at www.TrainerConnectOnline.com
