A NAGVA sanctioning fee (\$15.00 US per Team) will be assessed for each tournament. Tournament organizers will remit the sanctioning fee, along with the NAGVA authorization request form, to the Vice President of Tournaments, prior to the event. The sanctioning fee entitles the tournament organizers to the following:

- · Seeding and playoff brackets.
- General administrative assistance.
- General liability insurance coverage.

C. Sanctioning Fees

1. Team Fees

A NAGVA sanctioning fee (\$17.50 US per Team) will be assessed for each tournament. Tournament organizers will remit the sanctioning fee, along with the NAGVA authorization request form, to the Vice President of Tournaments, prior to the event. The sanctioning fee entitles the tournament organizers to the following:

- Current NAGVA Team Representative email contact information.
- Seeding and playoff brackets.
- General administrative assistance.
- General liability insurance coverage.
- · Specific court scheduling assistance.
- Online Registration
- Tournament specific page on NAGVA website with details for tournament

What is your rationale for this amendment?

Tournaments are requiring an increase of NAGVA RCs which falls under "general administrative assistance" as stated within the section. The increase will prevent a NAGVA Season Member dues increase.

In addition, tournaments using more than one facility must pay an additional \$350 per facility fee. An additional facility is one defined as where play is occurring on courts during pool play or tournament play in which those courts are not under the same roof or within 300 yards of the main facility, which requires additional work and representatives/appointments to cover NAGVA administration at that tournament.

a. If a tournament indicates use of an additional facility during the sanctioning process, but cancels the use of an additional facility before the tournament is held, the tournament will be subject to a penalty up to the full additional fee if cancellation is done within 5 weeks of the tournament date.

 - 2. Facility Fees

In addition, tournaments using more than one facility must pay an additional \$400 per facility fee. An additional facility is one defined as where play is occurring on courts during pool play or tournament play in which those courts are not under the same roof or within 300 yards of the main facility, which requires additional work and representatives/appointments to cover NAGVA administration at that tournament.

a. If a tournament indicates use of an additional facility during the sanctioning process but cancels the use of an additional facility before the tournament is held, the tournament will be subject to a penalty up to the full additional fee if cancellation is done within 5 weeks of the tournament date.

• What is your rationale for this amendment?

Tournaments are being staffed with more RCs and additional facilities automatically require an increase in RCs sent; this will alleviate a NAGVA Season Member dues increase.
