9 VOTED, To accept the document, “An Appeal and Appreciation to All Church Entities
10 and Members from the General Conference and Division Officers Regarding the 2015 General
11 Conference Session Vote on Ordination,” which reads as follows:

13 The essence of all Christian faith is a personal relationship with Christ, faithfulness to His
14 Word and Christ-like relationships in Christian community (John 17:3, 17, 20, 21; 1 John
15 4:7-11). There are times in the journey of faith when committed Christians may have differences
16 (Acts 6; 15). These instances necessitate mutual respect, thoughtful listening, heartfelt
17 understanding and submission to the Holy Spirit’s leading into unity (Ephesians 4:31, 32). This
18 is certainly true regarding the vote on July 8, 2015, on the subject of ordination at the General
19 Conference Session in San Antonio. Recognizing our differences we express grateful
20 appreciation to church members and entities for their acceptance of the world Church’s decision.

22 *Re-affirming the Role of Women*
23

24 We re-affirm that the Holy Spirit imparts gifts to all believers and that women play an
25 important role in the life of the church (Joel 2:28; 1Corinthians 12:11, 18). Their commitment,
26 giftedness, and talents are a blessing to the entire body of Christ. The vote taken in San Antonio
27 does not change the church’s understanding of the role of women in the life, mission and practice
28 of the church as supported by the *Church Manual* and outlined in General Conference and
29 division working policies. Godly, Spirit-filled women are powerfully witnessing for Christ and
30 being used by the Holy Spirit to make major contributions for the advancement of His kingdom.

32 *Moving Ahead Together in Mission*

34 The Seventh-day Adventist Church is a worldwide body held together by the Holy Spirit
35 through a commitment to Christ, mutually accepted biblical beliefs, a common mission and
36 worldwide organizational structure (Revelation 12:1; 14:6, 7, 12). General Conference Session
37 actions and voted policies are agreements that the body of Christ make together.

39 We appeal to all entities to respect the decision by the world body in session since any
40 unilateral and independent action contrary to the voted action paves the way for fracture and
41 fragmentation. We urge all entities to work closely with world division administrations to ensure
42 that all actions harmonize with voted policy to foster worldwide church unity and our heavenly-
43 entrusted mission.

45 In light of the urgency of our time and rapidly fulfilling Bible prophecies, we invite all
46 entities and church members to join us in a continuing commitment to Christ-like relationships,
