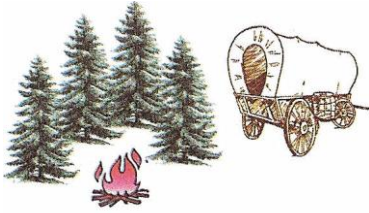

POLICIES OF TIMBER RIDGE CAMP

Timber Ridge Camp is owned and operated by the Indiana Conference of Seventh-day Adventist. Our mission is to provide a place to come apart and relax, enjoy nature and have fun in the great outdoors that God created. God created this world, along with us, and rested on the seventh day. We hold the sacred hours from sundown Friday evening to sundown Saturday evening as the Sabbath hours. Because of this, the horses, boat, swimming and some activities are not appropriate for the Sabbath and are not permitted. We do encourage other activities that would be appropriate for these sacred hours.

We also strive to maintain Timber Ridge Camp as a clean and healthy environment by encouraging all who enter to maintain safe and healthy lifestyles. In order to help promote these goals, we ask our guest to help us in this endeavor.

NO SMOKING is allowed in any of the facilities or on the property of Timber Ridge Camp.

NO ALCOHOLIC BEVERAGES are allowed on the property of Timber Ridge Camp.

*Proper care should be given to all facilities and equipment while on the property. **Any negligent or willful damage to facilities will result in monetary compensation.** either by the individual who caused the damage, or to the group sponsoring the activity.*

FACILITIES AND EQUIPMENT:

*Some equipment such as **washers, dryers, and ceramic kilns**, are not available for use by any group. **These are for CAMP STAFF use only!***

HORSES:

RIDES WILL BE CONDUCTED BETWEEN THE HOURS OF 9:00 AM AND 5:00 PM. No one is allowed in the horse barn, pastures or corrals unless they have permission of a staff member. All riders must sign an **“Equine Waiver and Release Form”**. No double riding or children under 7 allowed on trail rides. Pony rides will be provided for the younger children under 7, no charge.

SWIMMING: No one is allowed to swim or be in the lake unless arrangements have been made and risks understood, as we do not keep lifeguards at the waterfront at all times. Groups may bring their own lifeguards, or have TRC hire lifeguards for their event, as per price sheet. Groups will be responsible when there is no lifeguard on duty.

SPEED LIMIT: The speed limit while on the grounds is **10 mph**. Any dangerous or reckless driving could result in the driver being asked to leave the premises. There shall be no riding on hoods, trunks or any other part of a vehicle outside the passenger compartment. Those riding in trucks should stay seated inside the bed at all times. **Park only in designated areas. Vehicles**

parked in No Parking and Fire Lane areas must be moved immediately, or they will be towed at owner's expense.

PETS: While we do allow pets on the premises of Timber Ridge Camp, owners will be responsible for any damage caused by their pets and charged to repair any damages. No pets, except service animals, are allowed in cafeteria, cafeteria basement, Hainey and Deer Lodges. **Pets will be permitted in cabins only!** They must also remain on a leash at all times while on the premises. You must also clean up after your pet if it is in an area around buildings or in an area that others are using, and thus becomes a problem. All damage is the owner or groups responsibility. Timber Ridge Camp employees may have pets that are not subject to these rules.

KITCHEN: The Kitchen at TRC is not available for rental.

BUILDING AND EQUIPMENT CARE.

No food or drinks, except water, are permitted in the Nature Center or other designated areas.

No equipment, chairs or tables are to be removed from any building unless prior permission from camp manager or camp ranger. If you do have permission, your group is responsible to return said equipment.

HAYRIDES:

Hayrides are available for groups of one hundred (100) or less, providing arrangements have been made with the camp manager. Hay rides must start by 9:00 PM.

GOLF CARS:

Due to insurance reasons, Timber Ridge Camp golf cars are for camp staff or Indiana Conference personnel only, and therefore not for rent or use by others. No golf cars other than those owned by the camp will be permitted unless written permission is obtained and proof of insurance is given.

FOOD:

DUE TO COST AND TIME FOR PREPARATION, WE WILL NO LONGER PREPARE ALLERGY RELATED MEALS, SUCH AS GLUTEN AND SOY, ECT. WE WILL PROVIDE REGULAR AND VEGAN MEALS ONLY! ALL VEGANS MUST BE REGISTERED BEFORE ARRIVING! IF A PERSON HAS SPECIAL NEEDS, THEY MUST PROVIDE THEIR OWN FOOD ITEMS. Your group is responsible to relay the number of persons that will be eating each meal, ***including vegans.*** If you do not give an accurate number of vegans, we will not prepare extra once you arrive. ***YOU MUST TURN IN MEAL NUMBERS AND SCHEDULE TEN (10) DAYS PRIOR TO YOUR EVENT.*** You must give numbers for adults, children and vegans. You will be charged for the number of meals you ordered, if your actual numbers are less.

MEALS:

MEAL TIMES MUST BE COORDINATED WITH THE MANAGER TEN (10) DAYS PRIOR TO YOUR EVENT. MEAL TIMES WILL BE BETWEEN THE HOURS OF 7:00 AM AND 6:00 PM. PLEASE NOTE THESE TIMES! WE ONLY SERVE VEGETARIAN AND VEGAN MEALS.

MEALS ARE ALLOTTED A ONE (1) HOUR TIME LIMIT. AT THE END OF THE FIRST 45 MINUTES, ALL FOOD WILL BE REMOVED IN ACCORDANCE WITH THE GUIDELINES OF THE INDIANA DEPARTMENT OF HEALTH. THESE TIMES WILL BE STRICTLY ENFORCED, SO MAKE SURE YOUR GUESTS ARE ON TIME!

NO GUEST ARE PERMITTED IN THE KITCHEN UNLESS PERMISSION IS GIVEN BY THE PERSON IN CHARGE. EMPLOYEES ONLY!

A **“RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT”** must be signed for each guest on the grounds of Timber Ridge Camp, even if only visiting someone. Please make sure if you have any guest visiting, they sign the agreement.

Any infraction of these rules could result in some individuals being asked to leave the premises, or the loss of future use by your group.

Any group who does not inform TRC that they will not be utilizing the camp for their event, thus causing TRC to lose revenue, will lose their registration deposit and future dates.

GROUP LEADER MUST SUPPLY ALL GUESTS WITH A COPY OF THIS POLICY, THE “LIABILITY FORM” AND THE “EQUINE FORM” PRIOR TO ARRIVING AT TIMBER RIDGE CAMP. SIGN BOTTOM OF REGISTRATION FORM AND RETURN REGISTRATION FORM WITH DEPOSIT MADE PAYABLE TO: TIMBER RIDGE CAMP. BRING ALL COMPLETED RELEASE FORMS WITH YOU ALONG WITH A LIST OF ALL YOUR REGISTERED GUESTS WHO WILL BE ON THE GROUNDS. THE ADDENDUM TO THE USER-GROUP AGREEMENT MUST BE READ AND SIGNED UPON ARRIVAL TO THE CAMPGROUNDS PRIOR TO USE OF THE FACILITIES BY YOUR GROUP.

ALL MEAL NUMBERS AND SCHEDULES MUST BE SUBMITTED TO THE CAMP OFFICE TEN (10) DAYS PRIOR TO YOUR EVENT. AFTER THIS TIME, ANY INCREASE IN NUMBERS MAY RESULT IN AN UPCHARGE PER MEAL. FOOD WILL ONLY REMAIN ON THE SERVING LINES FOR THE FIRST 45 MINUTES DURING EACH ONE (1) HOUR MEAL TIME, DUE TO HEALTH CODES. EXTENDED MEAL TIMES AND SPECIAL MEAL REQUESTS, WILL RESULT IN AN INCREASE OF A MINIMUM OF \$10.00 PER MEAL, ABOVE PUBLISHED RATES. MEAL SCHEDULES AND MEALS MUST BE APPROVED BY CAMP MANAGER AND HEAD COOK PRIOR TO YOUR EVENT.

ALL PAYMENTS ARE DUE AT THE END OF YOUR STAY, UNLESS OTHER ARRANGEMENTS HAVE BEEN MADE. ALL CHECKS AND MONEY ORDERS, MUST BE MADE PAYABLE TO: TIMBER RIDGE CAMP

RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

IN CONSIDERATION of the undersigned or the undersigned's child or children being permitted to participate in and utilize the facilities, services and programs of the Indiana Association of Seventh-day Adventists, Inc. d/b/a Timber Ridge Camp (hereinafter "TRC"), including, but not limited to the observation, use of facilities or equipment, or participation in any on or off-site program affiliated with TRC, the undersigned, for himself or herself and for such participating children and any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents as follows:

1. THE UNDERSIGNED, ON HIS OR HER BEHALF AND BEHALF OF SUCH PARTICIPATING CHILDREN, HEREBY RELEASES, WAIVES, DISCHARGES AND CONVENANTS NOT TO SUE TRC, its directors, officers, employees, volunteers and agents (hereinafter referred to as "releasees") from all liability to the undersigned or such children and all their personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, or their participating children whether caused by the negligence of the releasees or otherwise while the undersigned or such children are in, upon, or about the premises or any facilities or equipment therein or participating in any program affiliated with TRC.

2. THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage or cost they may incur due to the presence of the undersigned or such children in, upon or about the TRC premises or in any way observing or using any facilities or equipment of TRC or participating in any program affiliated with TRC whether caused by the negligence of the releasees or otherwise.

3. THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE to the undersigned or such participating children due to negligence of releasees or otherwise while in, about or upon the premises of TRC and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with TRC.

4. THE UNDERSIGNED AGREES that if medical treatment of any type or kind be required by or for the undersigned or the undersigned's participating children that the undersigned or the undersigned's insurance company shall pay for all such medical treatment, including but not limited to, services provided by hospital, doctors or clinics and the undersigned shall indemnify and hold TRC harmless for all related medical expenses. THE UNDERSIGNED further expressly agrees that the foregoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of Indiana and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.

TIMBER RIDGE CAMP EQUINE WAIVER AND RELEASE OF LIABILITY

This WAIVER and RELEASE of LIABILITY is made and entered into on this _____ day of _____, _____, by and between the Indiana Association of Seventh-day Adventists, Inc. d/b/a Timber Ridge Camp (hereinafter “TRC”) and _____ as camper, and, if camper is a minor, camper’s parent or guardian, _____ (referred to collectively herein as “PARTICIPANT”). In return for and in consideration of PARTICIPANT’S participation in TRC’S equine activities now and in the future, PARTICIPANT, his/her heirs, assigns, and legal representatives, hereby expressly agree to the following:

1. Inherent Risks. There are significant elements of risk in any adventure, sport or activity associated with horses; horse drawn equipment and/or saddle animals including but not limited to horses, mules and donkeys (referred to herein as “activity”) and the use of any equipment therewith. The undersigned acknowledge(s) there are inherent risks associated with equine activities such as described below, and hereby expressly assumes all risks associated with participating in such activities. The inherent risks include, but are not limited to the propensity of equines to behave in ways such as running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in an injury, harm or death to persons on or around them; the unpredictability of equine’s reaction to such things as sounds, sudden movement, and unfamiliar objects, persons or other animals; certain hazards such as surface and subsurface conditions, collisions with other animals; the limited availability of emergency medical care; and the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within such participant’s ability.

2. PARTICIPANT acknowledges that horses, by their very nature are unpredictable and subject to animals’ whim, which may include behavior including, but not limited to their propensity to kick, bite, shy, buck, stumble, bolt, rearing or general unpredictability. PARTICIPANT assumes all risks in connection therewith, and expressly waives any claims for any injury or loss arising there from.

3. PARTICIPANT agrees to abide by and follow TRC’S rules and regulations which shall be posted and/or available from time to time.

4. PARTICIPANT further acknowledges that the behavior of any animal is contingent to some extent upon the ability of PARTICIPANT. PARTICIPANT shall assume risks therefore and warrants that a full and fair disclosure of PARTICIPANT’S abilities has been made to TRC.

5. PARTICIPANT agrees to hold TRC and all of its successors, assigns, subsidiaries, affiliates, officers, directors, employees, volunteers and agents completely harmless and not liable and release them from all liability whatsoever and AGREES NOT TO SUE them on account of or in connection with any claims, causes of action, injuries, damages, cost or expenses arising out of PARTICIPANT’S use of or presence upon TRC’S equines, property and facilities, including without limitation, those based on death, bodily injury, property damage, including consequential damages.

6. PARTICIPANT agrees to indemnify and defend TRC against, and hold it harmless from, any and all claims, causes of action, damages, judgments, costs or expenses, including attorney’s fees, which in any way arise from the Participant’s use of or presence upon the TRC’S equines, property and facilities.

7. In the event PARTICIPANT is using PARTICIPANT'S own horse, or a horse(s) not owned by TRC, PARTICIPANT warrants said horse(s) shall be free from infection, contagious or transmittable diseases. TRC reserves the right to refuse access or use of any horse upon the premises that does not appear to TRC to be in good health, or is deemed dangerous or undesirable.

8. Participant agrees that if medical treatment of any type or kind be required by or for Participant, that Participant or Participant's personal insurance company shall pay for all expenses incurred for such medical treatment including but not limited to services provided by hospital, doctors or clinics and Participant shall indemnify and hold TRC harmless for all related medical expenses.

WARNING

Under Indiana law, an equine professional is not liable for an injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities.

Addendum to the User-Group Agreement

Welcome to Timber Ridge Camp! We are so glad you have decided to spend some of your valuable time with us. It is our sincere hope that you enjoy your time here at Timber Ridge Camp and that you leave satisfied with the camp experience. If there is anything, we can do to make your stay here more comfortable, please feel free to let us know. Timber Ridge Camp is committed to running the safest, most efficient camp possible. Because of this desire, please familiarize yourself with the following information. All user-groups are required to abide by the information contained in this document. Enjoy your time here!

Orientation:

All group leaders must attend the camp's orientation meeting. This is crucial for all parties involved because it gives us an opportunity to share important information with you. Emergency procedures will be covered during this meeting. In addition, discussion of regulations for all camp-offered activities will be covered. You will be provided with a signed copy of this agreement, containing in writing, all the information covered during the orientation.

Food Service:

Only Timber Ridge Camp kitchen staff members are allowed to access and use the site's food preparation facilities. If you wish to have food provided to your group, please let the camp know of this in advance. You are welcome to cook out of your campsite, provided you exercise proper waste disposal techniques, and clean the area before leaving.

Transportation:

Timber Ridge does not provide emergency transportation for your group. You should have a vehicle that is constantly dedicated to the purpose of emergency transportation—or you should make contact with local EMS services. Here is a list of helpful emergency numbers:

In addition, please note that TRC prohibits the transportation of passengers in non-passenger vehicles. This includes the beds of pick-up trucks and the floor of vans with no seats.

Automatic External Defibrillator:

You should be aware that Timber Ridge Camp has two (2) Automatic External Defibrillator on-site. One is stored in the cafeteria next to the drinking fountains and the second is located in the back of the gym, next to the electric panel. If your group does not use the cafeteria for meals, you may ask the Camp Manager to make alternate arrangements to ensure the availability of the one in the gym. Please make sure your staff or group knows these locations.

Health Notices:

While you are using the facilities of Timber Ridge Camp, please be aware that:

TRC assumes no responsibility for your healthcare while you are here. We advise you to provide with your group at least one person who is CPR certified, First-Aid certified, and certified to deal with blood-borne pathogens. In the event of an emergency, having this person available can save a life.

First-Aid supplies should be brought by your group.

Emergency procedures and reporting requirements will be discussed during orientation.

We advise you to collect the following information for each of your participants:

Names and addresses,

Emergency contact names and numbers,

Listing of all known allergies and health conditions requiring treatment, restriction, or other accommodations, and

For minors without a parent on-site, signed permission to seek emergency treatment forms.

This information will prove invaluable in the event of an emergency.

Personal Property:

Please be aware that TRC strictly prohibits the possession and/or use of the following:

Alcohol, cigarettes and drugs

Weaponry

ATV's

Golf carts

Also, please understand that if you choose to bring your own personal sports equipment, you are responsible for it at all times. TRC will not assume any liability for damage.

Private vehicles are allowed, but must follow the posted 10 mph speed limit at all times. TRC reserves the right to restrict traffic if this becomes an issue.

No smoking is permitted anywhere on the grounds at Timber Ridge Camp. Any person found in violation of this may be asked to leave.

Timber Ridge Camp does not permit any skateboarding/mountain boarding/other types of boarding activities.

Campers must wear helmets while riding their bicycles at all times.

Waterfront Activities

Be Advised: TRC recommends that your group provide a certified lifeguard for each waterfront activity. This includes, but is not limited to: swimming, canoeing, and boating.

Be Advised: TRC recommends that your group provide an individual for each separate waterfront activity who is CPR, First-Aid, and blood-borne pathogen trained. This is for your safety.

Timber Ridge Camp staff members are the only ones allowed to operate the camp's motorboat. If you wish to utilize the boat, please make arrangements with the Camp Manager ahead of time.

For canoeing, please see the Camp Manager for a key to the canoe shed. Groups must provide person to manage equipment who will be responsible for the care and use during your stay. They should make sure all equipment is returned and stored properly.

Safety regulations for waterfront usage will be covered during orientation. Your group may also reference the large sign posted at the waterfront for a list of safety rules.

If you wish to have rescue equipment available, please make arrangements with the Camp Manager.

The use of Personal Flotation Devices is **MANDATORY** for **ALL** canoeing and boating activities.

No personal watercraft are allowed on Timber Ridge Lake, unless approved by camp manager and certificate of insurance provided.

Horseback Riding

All trail riders must sign an equine release form.

Be Advised: TRC recommends that your user group provide a CPR/First-Aid/blood-borne pathogen trained individual for each riding activity.

Timber Ridge Camp staff members are the only ones allowed to organize and operate horseback rides. If your group wants to use the horses, you must make prior arrangements with the Camp Manager, in time to hire wranglers for your ride. Please, refrain from entering the barn, pasture, or other riding facilities unless accompanied by a staff member.

Safety regulations for horse usage will be covered during orientation.

Trash and Refuse

Please put all your trash in sturdy trash bags and place in the large container located at the cafeteria, as this will help keep animals from scattering trash around the camp.

The release and waiver form must be signed by all guests of Timber Ridge Camp.

All release forms must be signed and delivered to camp manager during orientation meeting.
