At a regular meeting of the Buchanan City Commission, City of Buchanan, County of Berrien, State of Michigan (the "City"), held on this date October 28, 2019.

RESOLUTION TO SET MUNICIPAL PERMIT FEES FOR ADULT USE MARIHUANA ESTABLISHMENTS, MARIHUANA EVENT ORGANIZER, AND TEMPORARY MARIHUANA EVENTS IN THE CITY OF BUCHANAN.

WHEREAS, the City Commission has adopted an Ordinance allowing Adult Use Marihuana Establishments to operate in the City of Buchanan; and

WHEREAS, the City is authorized by the Michigan Regulation and Taxation of Marihuana Act to charge annual fees of no more than \$5,000 to defray the costs of application, administrative and enforcement costs associated with the operation of the marihuana establishments in the City.

NOW THEREFORE BE IT RESOLVED, the issuance of annual Municipal Permits for Adult Use Marihuana Permits is an administrative cost to the City and subject to annual fees; and

BE IT FURTHER RESOLVED, A nonrefundable fee shall be paid by each Marihuana Establishment Permitted under Ordinance 2019.11/413 in an annual amount of not more than \$5,000.00 as follows:

Marihuana Grower (all Classes): \$5,000.	Excess Marihuana Grower: \$1,500
Marihuana Processor: \$5,000	
Marihuana Retailer: \$5,000	
Marihuana Secure Transporter: \$5,000	
Marihuana Safety Compliance Facility: \$5,000	
Designated Consumption Establishment: \$1,000	
Marihuana Microbusiness: \$5,000	
Temporary Marihuana Event: \$1,000 plus \$500.00 per day.	

BE IT FURTHER RESOLVED, a nonrefundable fee shall be paid by each Marihuana Event Organizer of \$1,000 per event.
