## SECRETARY'S REPORT submitted by Beth Barberree

The following decisions and actions were made by this Board via electronic communication since October's meeting:

- Ron's comments on **ACTION: Charles and Beth to craft an appropriate protocol for consistent and fair deliberation of events by way of electronic voting between scheduled Board meetings.** 
  - Please be informed that myself, Beth and Charles are working diligently on this. Recent events have cemented the need. The January meeting is the timing goal.
- Gene Marshall player transfer from U of C to WCP was approved. We may need further discussion as to where league authority lies with respect to permissions on players changing clubs.
- Action item for Ron to review the Interclub Singles 6 Team Divisions where each team needs to add 1 match to their 14 week schedule.
- Background: The 6 Team Divisions are Ladies 1, Ladies 5, Mens 12 and Mens 13.
  - Historically there have been only 1 or 2 6 Team Divisions this season is the most that we have ever had.
  - A 6 Team Division is an 'unbalanced' Division whereby each team does not play each other an equal number of times some 2 times and some 3 times.
  - A consequence is unbalanced and unequal final standings. This can affect playoffs and promotion/demotion.
- Each Division has been reviewed and once again as in previous years the solution is:
  - 1) Each Team schedules a Week 15 'Floating Date' makeup match. This ensures that every team plays each other 3 times.
  - 2) Each Division then has 3 'Floating Date' matches to schedule at or before the Season End of April 7th.
  - 3) And the Webmaster can accommodate this easily.

The matches to be made up are:

- 1) Ladies 1 West Hillhurst/Bankers Hall, World Health/Southland, Winter Club/Mount Royal
- 2) Ladies 5 Southland/Bow Valley, West Hillhurst/Mount Royal, World Health/Glencoe
- 3) Mens 12 men's 12, Fit Plus at WCP, Winter Club/Fish Creek, Racquet Network/World Health
- 4) Mens 13 Fifth Ave/World Health, Southland/Fish Creek, Racquet Network/World Health
- Historically these matches have been played.
- Scheduling and playing these matches may involve some court access and availability issues on many Tuesdays, so, they should then be scheduled at any time and anywhere at or before the Season End of April 7th.

- Next step is arranging mutually agreeable dates and times for these matches. And Larry to setup the website. A review of the World Health and Southland options will begin immediately.
- Action Item 11.1 from our last meeting was for the Rules Committee Craig Hutchings to provide wording clarification of Squash Alberta Membership on the Rules Section of our Website.
- The wording clarifications are below with the Rule Number specified.
  3.0 Member "and is an annually paid for member of Squash Alberta,"
  - 6.1 Player Eligibility "becomes an annually paid Squash Alberta member ..."
  - 8.1 c ''ensure they are an eligible player paid for annual membership of Squash Alberta -
