



SCHOLARSHIPS 2019-2020 SCHOOL YEAR

Several scholarships are available to B.A.A. students. Churches, Central California Conference (CCC), Pacific Union Conference, and B.A.A. offer scholarships based on financial need. Contact your church for an application for church sponsored scholarships. The Pacific Union Conference Endowment scholarship application is available online on the CCC Education Department menu under scholarships. Application for Central California Conference Education Endowment Fund scholarships and B.A.A. scholarships are online at tads.com. TADS is a financial aid assessment service that works with families and schools to simplify the financial aid application process for both the family and the school.

CHURCHES

The church where parents and students are members may provide scholarships based on need. Contact the pastor or the church office for more information.

CENTRAL CALIFORNIA CONFERENCE (CCC)

CCC Endowment Fund

Eligibility—Both elementary and secondary students. Parents or applicant must hold membership in a CCC Seventh-day Adventist church and must demonstrate financial need. Students must maintain an acceptable academic record. Parents or a sponsoring church member must make a financial commitment to the local school. Applications are available online at www.cccsda.org in the Scholarship menu under TADS Financial Aid. There is a \$34 application fee. Deadline is April 30, 2019.

New Member Fund

First time students in grades K-12 who have been baptized or who have at least one parent who is a member of the Seventh-day Adventist Church and who was baptized within the last five years are eligible to apply for a 20% scholarship toward tuition for the first and second year in attendance. Applications are available through pastors and the principal. Open enrollment for the first year.

Three Way Matching Fund

Some churches participate in the Three-Way Matching Fund. The church, B.A.A. and CCC each provide \$300 for a total scholarship of \$900 per applicant. A maximum of seven scholarships are available to BAA. Contact the principal or pastor for more information. There is no application deadline.

Pacific Union Endowment Fund

Eligibility—Secondary students grades 9-12. Applicants must contact the principal prior to applying. Scholarships awarded vary based on the number of eligible applicants. Applications are available online at cccedu.adventistfaith.org/scholarships and in the B.A.A. office. Deadline is June 30, 2019 at the CCC Office of Education.

BAKERSFIELD ADVENTIST ACADEMY

BAA has a limited number of scholarships available including the PK-8 Scholarship Fund. Apply online at tads.com. TADS is a financial aid assessment service that works with families and schools to simplify the financial aid application process for both the family and the school. The application fee is a \$34. The application deadline is April 30, 2019. Scholarships are awarded based on financial need and the number of eligible applicants. TADS FINANCIAL AID ASSESSMENT PROGRAM

TADS is a financial aid assessment service that works with families and schools to create successful educational opportunities. TADS mission is to simplify the financial aid application process for both the family and the school, making it easier for you to offer your child a superior education. With TADS, families, and school working together, the potential of maximizing financial aid is significantly increased.

The online wizard and online chat assist you in every step of filling out your application. Applications are available in both English and Spanish. As a financial partner, TADS ensures your privacy by utilizing secure, encrypted data.

Families that request financial aid from Bakersfield Adventist Academy must complete an online application at tads.com. A link to TADS is located on the B.A.A. website under the Financial Aid tab. You will be asked to create an account with an E-mail address. Families applying for the Central California Conference Endowment Fund Scholarship use the same service. You must select both B.A.A. and Central California Conference to be considered for scholarships from both.

The deadline for applying for B.A.A. scholarships and the Central California Conference Endowment Fund is April 30, 2019.

Before you begin your online financial aid application, you should have the following information in front of you:

1. Payment form (credit card or checking account number)
2. Employment information for all parents and guardians, including: -- Most recent pay stubs and W---2 forms -- Actual gross income for each job during last year and estimated income for each job next year
3. Entire 1040 federal tax form
4. Any corporation, partnership or trust tax papers (1120, 1120S or 1065)
5. Monthly income, including: • Welfare • Food Stamps • Social Security • Child Support • Alimony • Other Income
6. Yearly income, including: • Interest and Dividends • Worker's Compensation • Unemployment • Other Income
7. Rent, renters' insurance, yearly energy expenses
8. Purchase price of home, additions, current market value of home, home loan amounts, mortgage payments, property tax, home insurance, rental income/expenses
9. Assets and expenses for real estate other than house; assets and debt for automobiles, recreational vehicles and boats
10. Checking, savings, cash, CDs, stocks, securities, bonds, mutual funds, yearly retirement fund contributions and total current values
11. Medical expenses and debt, day care expense, charitable giving
12. Miscellaneous debt including: • Credit Card • Bank Loans • Loan Companies • Loans from friends or relatives • Education • Other
13. Dependent earnings and saving
