

Objective

The objective of this award is to encourage members of the society to help shape the future of the financial management profession through writing and publication of compelling essays/articles.

Award Criteria

Entrants must be members in good standing of the American Society of Military Comptrollers at the time of submission and selection.

New for 2023! Authors may choose to write on any one of three current topics:

- 1. Over the past 75 years, the financial management career field has benefitted from some exceptional leaders. In your experience, who has been the most influential leader in your financial management career? Please describe the characteristics that make/made them good leaders and how those characteristics impacted your career.*
- 2. There have been numerous technological advances in financial management since ASMC was established. What do you predict for the next change in technology and what impact do you anticipate the change(s) will have on defense financial management in the future?*
- 3. Policies, Directives, and Instructions tend to follow changes in law, novel technological enhancements, or other emerging risks that jeopardize the effective protection/use of tax payer funds. As you reflect on the past and look to the future, what Policies, Directives or Instructions do you think should be modified to improve the effectiveness of financial management? In what way would you propose to modify it/them and to what effect?*

- Duo or group authored essays will not be accepted.
- Essays must be original, cannot be previously published and must not exceed 1,500 words.
- No member will be permitted to be a repeat winner for more than two consecutive years.

How to Submit an Essay

Essays must be submitted using the web based form through the nomination link at asmconline.org. Essays

may be submitted by an ASMC chapter representative or by the author directly.

Deadline

All essays must be submitted via the ASMC Awards Online website not later than February 28 to be considered by the selection panel. If February 28 falls on a weekend or federal holiday, the deadline is the next business day. There is no exception to this deadline.

Award Selection Procedures

A selection panel chaired by a member of the National Awards Committee and assisted by the *Armed Forces Comptroller* Editorial Board Chairperson will make final recommendations to the ASMC National Executive Committee, who will approve final award winners. The selection panel will include not less than four members representing a cross section of ASMC Membership. A judge must recuse him/herself if a conflict of interest exists.

Essays will be judged on adherence to topic (how well does the essay meet the contest topic), clarity and readability (how well does the essay flow and is it understandable), content (is the essay original and does it contain substantial content) and general administration (length, grammar, spelling, sentence structure, punctuation). Winners will receive email notification by 1 May and results will be posted on the ASMC website.

Recognition

Winners of the Essay Award may have their essays published in the *Armed Forces Comptroller* magazine and/or the ASMC website. Up to three winners will be selected each year from qualified essays. The first place winner receives \$750; second place receives \$500; and third place receives \$250. In addition, all winners receive a plaque, which is presented at the ASMC Professional Development Institute (PDI). A completed W-9 will be required before disbursement of the award check(s) to the winners.
