With determination in her heart, she traversed up and down stairs, proving time and again that she could conquer any obstacle in her path. As time went on, Carol faced another transition, this time to a wheelchair. Though this may have seemed like a daunting change, Carol adapted with grace and acceptance. The wheelchair did not define her; rather, it allowed her to continue living life on her own terms. She remained as independent as ever, showing us that true freedom comes from the strength within our hearts, not the mobility of our bodies.

After retirement, Bob and Carol's life was filled with the best of both worlds - they relished the thrill of traveling during winters in Texas, and at the same time, cherished the comfort and warmth of their summer home in McPherson, near their daughter Kendra and grand and greatgrandchildren.

On March 1st, 2018, Carol had to say goodbye to her dear companion, Bob. The pain of losing someone so close can be overwhelming, and Carol faced the challenge of navigating life without him by her side. Kendra and the family provided the support and assistance she needed. They became her pillars of strength, offering physical and emotional care, and ensuring she felt loved and valued every step of the way.
