#### 2.0 <u>OPENING</u>

The 2017 Annual General Meeting was declared open at 11.14am by the President of the Institute Lady Isioma Chukwuma. The opening prayer was said by Mr. Adeyemo Adejumo (A&E Integrated Services).

#### 3.0 NOTICE OF MEETING

The Director General read the notice of the meeting and confirmed that it was issued in accordance with the provisions of the Law.

#### 4.0 ADOPTION OF AGENDA

The Director General read out the Agenda for the 2017 Annual General Meeting. The motion for amendment of the Agenda to include presentation on the Institute's Victoria Island Building was moved by Mr. Adeyemo Adejumo (A&E Integrated Services) and supported by Mrs. Seyi Ifaturoti (Crystal Project Management & Claims).

#### 5.0 MINUTES OF THE LAST MEETING

#### 5.1 Adoption of the Minutes of the 2016 Annual General Meeting

The minutes of the Institute's 2016 Annual General Meeting which was held on Wednesday 13<sup>th</sup> July, 2016 at The Transcorp Hilton Hotel, Abuja were taken as read and subsequently adopted based on a motion moved by Mrs. Yetunde Ilori (Axa Mansard Insurance Plc) and seconded by Mr. Teju Ogunjimi (Smoothway Insurance Brokers).

#### 6.0 **<u>REPORTS OF THE GOVERNING COUNCIL</u>**

#### 7.2 Auditors Report

The Auditors, Adewuyi Adetunji & Co. represented by Mr. Adeyemi Adetunji confirmed that the firm audited the Institute's financial statements in accordance with the International Financial Reporting Standards (IFRS) on Auditing. He also confirmed that the firm obtained information and explanations which it considered necessary in order to give reasonable assurance that the financial statements gave a



true and fair view of the Institute's financial statement as at 31st December, 2016.

Members in their contributions commended the growth noticed in the report. It was however suggested that the assets of the Institute should be revalued.

The Report of the financial year ended 31st December, 2016 and the Auditor's Report were adopted following the motion moved by Mr. Kunle Ahmed (Axa Mansard Insurance Plc) and Mr. Shola Ajibade (Continental Reinsurance Plc).

#### 8.0 APPOINTMENT OF AUDITORS

The Treasurer, Mr. Eddie Efekoha, moved the motion that Messrs. Adewuyi Adetunji & Co. be reappointed as Auditors for the following year at a fee to be determined by the Governing Council of the Institute.

The motion was seconded by Mr. Adedeji Lasisi (Aceline Insurance Brokers Ltd), and thereafter adopted.

The applicant must submit the names of two referees who are Professional and financial members of the Institute.

The applicant must submit a letter of attestation to professional integrity by his/her employer.

The applicant must appear before the Membership Committee for an interactive session.

New members without the opportunity of having served in any committee of Council must show evidence of participation in Institute's activities.

Candidates must satisfy any other condition that may be approved by the Governing Council as it deems appropriate.


