HALL OF FAME POLICY

Policy Overview

Squash Australia has implemented a Hall of Fame Policy. This policy takes effect immediately.

What is a Hall of Fame Policy?

The Hall of Fame Policy sets out the expectations of Squash Australia LTD with regards to the Hall of Fame.

HALL OF FAME POLICY

OVERVIEW

1. The Squash Australia Hall of Fame has been established to assist the preservation of Australian Squash history and to publicly recognise the outstanding sporting achievements of squash athletes who have achieved the highest levels in the sport.

HALL OF FAME CATEGORIES

2. Only individual athletes may be inducted into the Squash Australia Hall of Fame.

3. There are two status levels:

Legend

Reserved for the athlete who has achieved the highest levels of squash internationally and nationally and has assisted Australian squash to become a world leader in the sport.

Member

Athletes who have achieved the status of World Champion or ranked No. 1 in the World during their playing career, or achieved significant results that place them in the highest standing among other elite athletes.

ELIGIBILITY

4. Membership to the Squash Australia Hall of Fame is limited exclusively to the top echelon of athletes.

5. The nominee will:
 - (a) be an Australian citizen;
 - (b) be a superior achiever at the highest level of competition;
 - (c) have provided outstanding support to Australian Squash over a period of not less than ten (10) years;
 - (d) have the support of their peers; and
 - (e) have been retired from professional competition for at least 12 months.

NOMINATIONS

6. Any person involved in Squash in Australia may nominate a candidate.
7. Nominations must be submitted on Annex A of this regulation.
8. Nominations for the Squash Australia Hall of Fame are to be submitted to the CEO of Squash Australia Limited by the first (1st) Friday in December each year.
9. All nominations will be investigated and evidence of achievements recorded.
10. The Board shall identify suitable inductees and prioritise for induction on an annual basis.

SELECTION PROCESS

11. A comprehensive list of all nominees shall be collated including
 - (a) nominator and year of nomination;
 - (b) highest World Ranking achieved;
 - (c) Event Results including World Open; British Open; British Open Masters; PSA Super Series and Masters; WISPA Grand Prix; World Amateur; Commonwealth Games; World Cup; World Doubles; World Teams (Junior and Senior), World Individual Juniors and any other event deemed suitable for inclusion; and
 - (d) any other information deemed relevant.
12. The Board will:
 - (a) consider the suitability of nominees according to the criteria detailed in Paragraph 5;
 - (b) Categorise all nominations as:
 - (1) players under consideration
 - (2) players requiring further research
 - (3) athletes not meeting the eligibility criteria.
 - (c) decide the athlete's suitability for induction, the status the nominee should be inducted (e.g. Legend or Member) and the proposed year of induction.
13. The Board will have the final approval of any athlete inducted into the Squash Hall of Fame.
14. In its deliberations the Board will consider:
 - (a) a nominee who is part of a team on the same basis as it considers any individual nomination;
 - (b) the degree of difficulty for a nominee to attain the highest level of achievement;
 - (c) in addition to a candidate's individual achievements, that person's integrity, sportsmanship and character; and
 - (d) nominees (as a general rule) in the following eras:
Pre 1925, 1926-1950, 1951-1975, 1976-2000, 2001-onwards.

PRESENTATIONS

15. The CEO will advise inductees of their entry to the Hall of Fame by the following first (1st) Monday in August of their recommended induction by the Squash Australia Board.
16. The public announcement and official induction into the Squash Australia Hall of Fame will be made at a time and place agreed in liaison between Squash Australia and the award recipient.
17. It is recommended that all inductions into the Hall of Fame be held in conjunction with the Annual Squash Australia Awards Evening.
18. The award shall take the form of a framed certificate provided by Squash Australia.

RECORD KEEPING

Annual Report

19. The Hall of Fame inductees will be recorded in the History section of the Squash Australia Annual Report and on the Honours Board at Squash Australia.

20. Details of the inductees to the Squash Australian Hall of Fame and nominees under consideration can be found on the Squash Australia file "Squash Australia Hall of Fame", which is held and maintained by Administration Staff.
