The President and Chief Development Officer will play a pivotal role in shaping the future trajectory of Vitalant's philanthropic endeavors through the Vitalant Foundation. With a focus on strategic leadership, collaboration, and fostering meaningful relationships, the President and Chief Development Officer will spearhead the formulation and execution of philanthropic strategies for the Vitalant Foundation. Collaborating closely with Vitalant's Senior Leadership Team, the President and Chief Development Officer will assess and refine development programs, philanthropic endeavors, and grant solicitations to bolster Vitalant's mission. The President and Chief Development Officer will partner with the Foundation Board of Directors to cultivate sustained funding opportunities, prioritizing Vitalant's critical objectives and enhancing its community presence. Success in this role will be measured by the ability to secure substantial financial support, drive strategic initiatives such as planned giving campaigns, elevate Vitalant's profile in local communities, and cultivate meaningful relationships with potential sponsors and donors.

Founded in 1943, Vitalant is one of the nation's largest nonprofit blood and biotherapies healthcare organizations, providing hospitals and patients across the U.S. a safe blood supply. Vitalant has a network of approximately 115 donation centers across the U.S. and hosts approximately 60,000 blood drives annually. Vitalant provides blood and special services to patients in about 900 hospitals across the U.S. — millions of people depend on blood donations from its generous volunteer donors.

The dedicated team at Vitalant makes sure lifesaving blood is available when and wherever it is needed. But Vitalant is more than a blood center. It also provides specialized laboratory services, transfusion medicine expertise, and cutting-edge research. Vitalant Research Institute is world-renowned for scientific studies ranging from blood donor epidemiology to cellular therapy and virus discovery. Vitalant is a partner in the operation of Creative Testing Solutions, the largest independent blood donor testing organization in the U.S., which tests 70% of the nation's blood supply. Vitalant is also a founding member of AABB (a professional organization that provides standards development and accreditation for blood centers) and was a driving force in the creation of America's Blood Centers (a consortium of independent community blood centers throughout the U.S. and Canada, including Vitalant). Both organizations play a major role in communicating advances in transfusion medicine nationwide.

Vitalant is an internationally known and respected leader that continues to push the boundaries to advance the experience, practice, and application of transfusion medicine. Individuals generously donating blood, volunteering, and giving financially are essential to its lifesaving mission of uniting blood and biologic donors, talent, and innovation to save and improve lives.

Every day in the U.S., patients in hospitals, surgical centers, and emergency treatment facilities need approximately 29,000 units of red blood cells, 5,000 units of platelets, and 6,500 units of plasma. The impact of blood donations is lifesaving, but the nation's blood donor base continues to shrink. Financial gifts help address this challenge by funding critical donor recruitment initiatives and blood center operations. In addition to supporting the daily blood needs Vitalant meets, gifts also support research in donor and patient safety. Recent research includes Vilalant's involvement in work conducted at the onset of the COVID-19 pandemic to support patients with developing technology, as well as the ADVANCE study, which has led to additional changes in blood donor eligibility.

Vitalant Foundation is changing lives through financial contributions. Financial gifts to Vitalant Foundation help ensure blood is available for patients in need and enhance research opportunities to support blood donors and recipients of the future. Vitalant Foundation is the official fundraising arm of Vitalant. As one of the nation's largest nonprofit blood and biotherapies healthcare organizations, Vitalant is uniquely positioned to become the nation's most innovative and inclusive blood and biotherapies partner. Vitalant Foundation secures and stewards charitable gifts to support Vitalant's mission to unite blood and biologics donors, talent, and innovation to save and improve lives.

Vitalant Foundation, formerly known as Blood Science Foundation, was incorporated as a tax-exempt organization in 1987. The Institute for Transfusion Medicine (ITxM) was also the parent company of Central Blood Bank and Lifesource serving the Pittsburgh and Chicago regions respectively with blood collection, testing, and distribution services before ITxM merged into Vitalant in 2017. From 2008 to 2016, the Foundation granted contributions to tax-exempt organizations totaling approximately \$25 million. In 2017, Blood Science Foundation became an independent charity following the merger of ITxM with Blood Systems Inc. In 2018, Blood Systems, Inc. was renamed Vitalant.

Vitalant Foundation is currently supporting a range of initiatives that include the Blood Bank Technologist Training Program, which fights the shortage of skilled laboratory professionals by expanding the workforce of certified blood bank technologists while also providing new opportunities for secondary education graduates to engage in meaningful careers. The Foundation also sponsors community blood drives to increase blood donations and raise awareness as well as supporting the costs of a bloodmobile— a mobile blood donation center that meets the blood donors where they are, helping to make donation easy, convenient, and comfortable. Financial support also helps the Foundation to grow the donors of African heritage through community-centric outreach in Black communities, which will ultimately save and improve the lives of sickle cell patients, 98% of whom are Black in the U.S.—while also advancing blood science research and racial equity in healthcare and overall, within American society. Vitalant Foundation also supports and celebrates high school students who attend schools that host blood drives by awarding them scholarship funding, which can promote increased community blood donation awareness and lifelong recurring blood donors.

Every two seconds someone in the U.S. requires a blood transfusion, equating to 4.5 million people needing a blood transfusion each year in the U.S. The work of the Vitalant Foundation ensures Vitalant can continue to provide these lifesaving measures.

He also served as Chairperson of Blood Centers of America, and President of America's Blood Centers and AABB. He is an Army veteran and received a bachelor's degree from Knox College and a master's degree from Central Michigan University.
