# a. Player Eligibility/ Reporting (Alex Altamirano and Kurt Kennedy / Wes Mah)

- i. Player Eligibility: Squash AB membership automated renewal was a great success for almost all players. Some players did not acknowledge the automation and they have been penalized. Up to now there have been 21 cases of not having a valid membership and 2 of these cases are for the same player.
- ii. Emails regarding eligibility go to the captain of the team and the club representative.
- iii. Any review of the penalty points a player has been assessed go to the rules committee for decision.
- iv. Most of the players have renewed their membership. Only 2 players are 'new' and in most cases it is renewals that were not accepted or they were rejected through the Squash Alberta site.
- v. Captains have been prompt to update the scores prior to the Thursday night cutoff.
  - $\circ~$  By Friday at noon Alex reaches out to Captains and Reps to get the results entered into the system.
- vi. Reporting requirement from ClubLocker:
  - $\circ$   $\;$  Trying to resolve an issue for the information that ClubLocker needs.
  - We do not have rankings in the system for the upcoming tournament (Calgary Open at U of C) and in the near future they will have rankings updated on a weekly basis on Monday nights.
  - Almost everything has been figured out so SportyHQ can send the proper data to ClubLocker.
  - Long term goal is to not have a lot of manual work behind the scenes.
- vii. If representatives are hearing concerns from members please do not hesitate to bring up concerns to the Reporting committee (Squash Alberta Membership, Rankings or otherwise)
- viii. Driving factor for ClubLocker was to have a Canada Wide rating system (not a ranking but a rating) Squash Canada is going through the pains of slowly transitioning to this new rating system
- ix. All results are time stamped and will put all of the rankings in orders when they are all entered into the ClubLocker system.
