- Vice President Rick Spyker

- o Bank balance: \$24,445.54
- Some clubs have not paid club fees yet: BVAC, Fifth Avenue Club and Edgemont Athletic

- No outstanding payments from sponsors
- We having issues with our account in TD.
 - Looking at perhaps changing accounts within TD or moving to RBC instead
 - Anthony Reimert, Mount Royal University works at RBC and it may make things easier
- Director, Community Relations
 Ron Coggan
 - There is a situation from Banff / Canmore (especially Canmore) where there is some players that would like to play Interclub. May have position available at SAIT, depending on the level.
 - Major thing in Banff is the Junior Outreach Squash Program for Aboriginal players has been an issue; however there is another outreach program that include refugees, temporary foreign workers (young adults) which is promising for the Bow Valley corridor.
 - o Arranged a discounted membership at the Banff Rocky Mountain Resort until June.
 - Ron is also able to provide equipment, if they sign up for the membership.

b. Committees

- Player Eligibility/ Reporting:
 - Player eligibility: Relaxing a little with Alberta Membership. Allowed people (unofficially) up to 2-3 weeks just to give people the opportunity to play. Most people do pay. If there are any issues Alex suggests that we make a motion to apply rules.
 - Reaching out to some captains that don't seem to know the rules. Club reps will need to make sure the captains in their respective clubs know the rules. Reaching out to rules committee to enquire. Also check if players played twice in the same night. Normally only check end of season or every 3 months since it's manual to gather information.
 - Reporting: Automation between SportyHQ / ClubLocker has been working well. There are some (minor) issues; however Ken Cross has been able to assist quickly. Some captains still not putting the scores in on time but they are generally pretty good.
 - Scheduling: Alex sent message to all captains (reps have been informed prior and not cc'ed in the latest emails) for their input on any changes to the schedules. Alex received 49% have been played are rescheduled. Some divisions have not done anything. Some divisions (83%) are complete or provided the required information. Information needs to be provided to Alex and needs to be in a specific format so that it can be updated in SportyHQ. This is important, because, if matches are not played, it will mess up the ranking, etc. We are getting to end of seasons and running out of time to get the matches in. Matches can be played at other clubs or on nights other than Tuesday in order to get them in.

- Rules:

- Sub-down issue:
 - Proposing a change to the sub-rules; especially subbing down:
 - *** See email from Keith ***
- Issue was brought up by the committee and hence the Rules Committee reviewed the rules and came up with this recommendation. Especially to address the abuse the sub rules, in the case that the clubs use subs from 2 levels higher.
- o 2 rule changes proposed. Motion: Keith for new rules. Alex seconded. Discussion:
 - Wes: Does not think it's needed.
 - Ron: Someone was of the opinion that the rule was not upheld in a particular situation.
 He does not think it's needed.
 - **Harvey comments:** Confusion around subs filling in at a particular situation and the person did not believe the rules were being upheld. If the rule does get passed, it may even encourage the captains to do this. Captains monitor and should bring it up. Comes down to educating Reps / Captains.
 - Ken feels players know levels and know when they get someone too good for their level. Reps should have meeting with captains to discuss interclub being fair play.
 - Alex policing the rule is not easy nothing in the system to help with it so it is manual.
 Could also change the rules that, if a sub is being pulled down, that person needs to play in position 1. If going up, maybe play in 4th position. The rules are there and can be used to protect teams from abusing the sub rule. It is also the spirit of the game.
 - Mark Need to emphasize the spirit of the game and ranking the positions appropriately, instead of playing around with the ranking to take advantage of players / positions. Need players / captains to follow up and complain.
 - Rick With ability to reschedule matches, if 2 players are required, reschedule instead.
 - Vote to adopt rule changes in the next season: 3 for; 7 against and 1 abstain.
 - Motion denied.
 - Action: Need to educate reps / captains to understand the current rule, the spirit of the rule / interclub and report any misuse. Communication to go out prior to next season.
- Rules committee to look at the rules to be applied at the end of the season due to reschedule of matches.
