Patty Lew-Lapointe

- \$15,000 currently in bank account
- Deficit for year \$4000 before SA rebate after rebate, will be flat/even and will bring cash balance close to \$20,000 - a few more monies from the Banquet and Expenses to come in still
- In good shape but cognizant of upcoming costs like the website but healthy enough to survive a year with no revenue
- Due October 1, 2016 filing.
- SA chq will be reissued the next week and couriered to Chris W.
- v. Director, Community Relations Ron Coggan
 - This Saturday (June 18, 2016) is All-Sports Calgary. At Southland Leisure Centre, there are 30 kids enrolled already. Kevin Doucet will be instructing while Ron Coggan and Arash Ardeshiricham will be welcoming the kids and providing handouts to the parents with information regarding squash. This is the 3rd year for All-Sports Calgary. Best is the ability to follow-up with the parents and the kids attending that did not happen in the last 2 years. Last year, only 3 or 4 kids joined a squash program following the All-Sports Calgary day. Most of the kids want to be somewhere south but not at MRU.
 - There will be a junior program at Fish Creek 0
 - Will track and hope to be more successful this year 0
 - Spend half day with City of Calgary and discussed the evolution of the sport of squash within the City
 - In Canmore, attended an updated Recreation Master Plan meeting. Originally there was no provision for squash but now squash is a top 4 priority out of 20 indoor sports based on results of a survey of residents of Canmore.

b. Committees

- i. Bylaws
 - Craig Hutchings presented by Charles Fair 2nd revision circulated to Exec, this group and SA
 - Feels that there needs more consideration, especially the address of the purpose/mandate of CISA.
 - 0 Is it the development of squash?
 - Feels more consultation with SA is needed.
 - Timing of the AGM annual report is not available in June when the AGM is usually held; perhaps a bit out of sync
 - Peter expresses a concern about having a new Executive team starting after the season has started (in September or later).
 - Charles wonders if the fiscal YE can be moved

- Chris confirms that the current YE is set at June 30, and the filing due date is Oct 30 because our incorporation is Sept 30.
 - It is possible to change the YE to May 31?
 - Chris is concerned about lagging expenses at May 31.
 - Rick likes the alignment of financial statements to be available at the AGM
- SA will not allow a member of CISA to sit a SA meeting per the Bylaws but a member of SA will be at all CISA meeting
- A further meeting between SA and the Bylaws Committee will address the purpose/mandate of the By-Laws
- Term limits the Executive team voted 3 to 2 to have no term limits
 - Everyone has an opportunity to be a part of the Executive once a year at the AGM
 - Don't want to limit someone in a position but if no one expresses an interest for a position, it can leave the position vacant

Motion to Support the Executive Term limits as written in the draft (#2) Bylaws – Limit of three years at one position to a max of six years on the Executive Team.

In reality, it is the incumbent who will take over the position when there is other interest expressed in a position. Yet this is not reflected in the Bylaws

Motion Failed. Term limits to be removed from the Bylaws and reflected in the next draft

- Feedback Peter would like the voting of the Bylaws at the August meeting. This means that the By-Laws need to be sent to the membership-at-large by July 15.
 - Executives would like to see the drafts by June 30 before sending out to the membership-atlarge
 - Goal is to get some better albeit not perfect Bylaws ready for voting at the August meeting. Let's use the 80/20 rule.
