Welcome and Program Overview

Associated Builders and Contractors Rocky Mountain Chapter (ABCRMC) invites member companies to enter their best project/s in the 2024 Excellence in Construction and Safety Awards recognizing outstanding Merit Shop projects.

All award winners will be recognized at ABCRMC's award celebration to be held on October 22, 2024. The ceremony will highlight the Excellence and Merit award-winning projects. All winners will be recognized in a special section of the Merit Builder Magazine and a news release for Excellence and Merit winners will be distributed to various media outlets.

Entry Requirements

Each entry must follow the entry requirements outlined in this award application.

ABC Membership

Only ABC Rocky Mountain Chapter members are eligible to enter. We allow applicants to apply as a joint- or triventure if all contractors are ABC members.

Project Safety Requirement

No project that involves prime, multi-prime or sub-trade contractors with a safety-related fatality is eligible to be considered for an award. ABC Nationally and locally disqualifies any project where the company experienced a safety-related fatality within the current program year (10/16/23 to 10/15/24). If there is a question regarding this policy and application requirement, the applicant may request clarification from the National EIC Committee by emailing EIC@abc.org prior to submission of the project.

A company that experiences a safety-related fatality of a direct employee in the United States within the current program year* is NOT eligible for an Excellence in Construction and Safety Award. If a subsidiary is a direct ABC member versus part of a larger holding company member, then the subsidiary with a safety-related fatality is not eligible, but another subsidiary of the same holding company may be. Furthermore, all EIC award winners have a continuing duty to inform ABC of a safety-related fatality that occurred after the end of the current program year until the time of the awards program. Such a fatality will nullify the EIC award. After the judging process and prior to the awards program, ABC will request that an award winner confirm that a safety-related fatality did not occur. Failure to respond to the request will also nullify the EIC award.

A company that experienced a safety-related fatality of a direct employee in the United States within two or three years of the current program year* is required to provide additional information regarding action that has been taken following the fatality.

No project that involves prime, multi-prime or sub-trade contractors with a safety-related fatality is eligible to be considered for an award.

If there is a question regarding this policy and application requirement, the applicant may request clarification from the National EIC Committee by emailing EIC@abc.org prior to submission of the project.

Completion of Project Requirement

To be eligible for award consideration, the project itself must be substantially completed by **Tuesday**, **October 15**, **2024**. Projects completed prior to **October 16**, **2023** are not eligible to participate.

Project Entry Steps & Deadlines

- Monday, June 3, 2024 -- Intent to Compete Registration opens and closes Friday, September 13, 2024 at 11:59pm (MDT)
- Saturday, September 13 -- Saturday, September 21, 2024 First Round of Judging will commence
- Saturday, September 21 -- Saturday, September 28, 2024 -- Second Round of Judging will commence if necessary
- **First Week of October 2024** Winners will be notified and we will celebrate the recognition at our annual Excellence in Construction® and Safety Awards on the 22nd of October.
- EIC Registration fees of \$400 are due no later than Friday, September 13th at 11:59pm (MDT)

Overview of Award Categories

Awards may be presented in differentiated categories; 40+ each for General Contracting and Specialty Contracting. Local Only categories number 15 different areas.

*Note that the awards listed for the Local Competition Only section are not eligible for National Award consideration

Excellence Award (1st Place)

Only one Excellence Award will be given in each category. Winners at this level are eligible to compete at ABC National's EIC Competition

Merit Award (2nd Place)

Up to two construction projects in each category will be eligible for a Merit Award. Winners at this level are eligible to compete at ABC National's EIC Competition

Letter of Commendation (3rd Place)

Letter of Commendation winners are not eligible to submit to National ABC's EIC Awards. ABC RMC recognizes winners at this level but does not hand out an award at the awards ceremony. Winners at this level are **not** eligible to compete at ABC National's EIC Competition

Other Special Awards

Special Recognition for Design Build

Special recognition will be given to projects that are design-build, through an ABC partnership with Design-Build Institute of America (DBIA). To be considered for this award, email the following information directly to Jen Hight (jhight@abcrmc.org) by the submission deadline. Note: The OpenWater platform is not set up to receive this information. You'll need to email it. A confirmation will be sent upon receipt.

- Provide a written narrative of no more than one single-sided page.
 - Describe what the design-build best practices were applied to the project.
 - Describe how the information was shared across the project team.
- Include a copy of the organizational chart, showing the design-build team's structure and contractual relationships.

Greener Tomorrow Award

Projects that used sustainable best practices are eligible for a Greener Tomorrow Award. To be considered for this award, email the following information directly to Jen Hight jhight@abcrmc.org by the submission deadline. Note: The OpenWater platform is not set up to receive this information. You'll need to email it. A confirmation will be sent upon receipt. **Note:** LEED certification is not required.

Provide a written narrative of one or two single-sided pages including:

- Describe the sustainable building initiatives, if any, which required your company's participation.
- Describe your company's involvement in the design phase, if any.
- Describe any obstacles of challenges related to achievement of the project's green initiatives.
- Indicate if the company is an ABC Certified Green Contractor
- If ABC Green Building Toolbox talks were used, include a sample of toolbox talk and sign-in sheet.

In addition, please provide the following:

- If applicable include green rating system used and level of certification achieved.
- If it's a LEED project, include the LEED score card.
- If another rating system was used, list the criteria used to establish the rating achieved.

Free Enterprise Award

Awarded for using the most ABC members on a job submitted for EIC.

Excellence in Marketing

Awarded to the person(s) who designed and produced the contents of the submission. No extra submittal needed to qualify for award.

Judging Criteria

The panel of judges represents a cross section of construction industry experts, including owners, architects, engineers and other industry leaders. The competition is comparative, using a point system to assist in the comparisons. A project entry can earn a total possible score of 100 points. All documents must be uploaded as a PDF unless otherwise noted. The quality of an entry's presentation will have a great impact on its opportunity to win.

Materials Submission

All submissions for the 2024 Associated Builders and Contractors Rocky Mountain Chapter Excellence In Construction and Safety Awards must be submitted online through the OpenWater Platform. To assist members with the transition, this application guide has been updated so that the required materials are listed in the order they are requested by the platform. Please note, all documents requested must be uploaded as a PDF file, unless otherwise noted.

Once payment for your entry has been processed, you will receive a link to begin working on your submissions. You don't need to upload all documents at one time. You can save your progress and return. You don't have to submit in the exact order listed below, though it is strongly encouraged to make one final review to ensure all documents have been uploaded before clicking the **Save and Finalize** button at the end of the Project Entry Qualifications, Rights and Agreement segment. Once you save and finalize, no further changes may be made to your entry.

Was this project completed by a joint venture?

ALL companies must be ABC members in order to enter as a joint venture. If only the majority partner is an ABC member, the project is eligible but not as a joint venture project. If only the majority owner is an ABC member, but not all partners are ABC members, only the majority owner is eligible to enter. Minority partners are not eligible.

Are all parties of the joint venture members of ABC?

Both companies must be ABC members in order to enter as a joint venture. If only the majority owner is an ABC member, the project is eligible but NOT as a joint venture project. If only the minority owner is an ABC member, the project is NOT eligible. Please contact your ABC chapter for additional guidelines

Project Description

If the project is an award recipient, the project description may be printed in the event program, as well as read from the stage at the awards gala. <u>It is subject to editing and may be changed by ABC staff.</u>

The project description should be between 30 and 40 words long and highlight the most impressive/unique aspects of the job. Key points to consider:

- Significant number of man-hours worked without an incident
- Unusually fast-track schedule
- Extensive collaboration with the owner or other project stakeholders
- Significant weather events
- Whether work was completed under budget or ahead of schedule
- Innovative technology or project delivery methods used
- Sustainable elements of the job
- Impressive project size or quantity of materials used
- Site constraints
- Significant changes in scope

Note: you will be unable to submit your final project if your description exceeds 40 words. You will receive an error message upon submission.

Contracted Scope 10 Points

Ensuring legibility when selecting font design and size, provide a description (no more than one full page) of the scope for this project with the following information:

- Type of construction
- Type of construction (i.e. lump sum, contract plus, type and material, unit pricing, etc.)
- Size of project
- Contract value
- Duration of project
- Percentage of labor that is self-performed
- Any subcontracted work performed by fellow ABC members, suppliers or associates/industry professionals, if applicable.
- Opportunities you provided to the construction community to participate based on merit.
- Upload Contracted Scope PDF files only

Project Narrative 30 Points

Ensuring legibility when selecting font design and size, provide a written narrative (no more than four pages*) indicating why this project is special and why it qualifies for a national award. The focus of the narrative should be the construction (i.e. erection, installation, modification, grade footprint, etc.) of the project. Four pages are highly recommended and photos/images may be incorporated. Be sure to include the following items:

- Describe any innovative programs relating to quality control
- Describe any innovative programs relating to scheduling
- Describe any value analysis/engineering process used on the project
- Indicate any special obstacles you overcame in completing the project
- Describe any difficulties or extenuating circumstances encountered in completing the project
- Describe any innovative programs or methods relating to productivity (see bonus award section of this application guide)

^{*}Projects entered into the Community/Public Service categories are allowed one additional page (for a total of five pages) dedicated to describing why the project qualifies for the category. This will be uploaded separately following the project narrative and should include a detailed description of the resources your company donated

Photographs

8 Points

Submit up to 10 high-quality photographs <u>in jpg or png format only</u>. It is recommended to include photos that are relevant to the challenges and solutions outlined in the narrative. To obtain maximum points, all projects should include "in progress" photos in addition to the completed project. Restoration and Renovation projects should also include "before and after" images.

- Single jpg files may include up to two photographs, but no more than four files should include split images.
- Provide a descriptive caption for each file in the text box provided, but keep the photograph free of any labels, captions and borders/framing. Each caption should not exceed 50 words.
- Ensure the photographs are free of any safety violations.
- Ten photographs are strongly recommended. Files should be a minimum of 300 DPI resolution and in jpg format. Please don't submit PDF files. They will be rejected.

Occasionally, entrants have asked that certain photos not be used in programs or on public sites, due to certain sensitivities, such as the exterior layout of an embassy. Indicate if any of the photos submitted meet this condition and specify which ones must remain private.

If any photos being submitted were taken by a third-party photographer, the photographer's written authorization to use the photos is required. In order to comply, you must upload a copy of the signed licensing agreement found on at www.abc.org/eic with the photographer's signature. No changes are allowed to this document.

Project Safety 31 Points

Did the applying member company have a safety-related fatality in the United States within the current program year specified by the chapter? No company that experiences a safety-related fatality of a direct employee in the United States within the current program year specified by your local chapter rules is eligible to submit a project.

If a subsidiary is a direct ABC member versus part of a larger holding company member, then the subsidiary with a safety-related fatality is not eligible, but another subsidiary of the same holding company may be. Email your chapter with any questions.

Did this project have a safety-related fatality?

No project that involves a prime, multi-prime, subcontractor or any trade related work that has a safety-related fatality —regardless of the type of contract—is eligible for an Excellence in Construction and Safety Award.

Past Company Fatality

Did the applying member company have a safety-related fatality within two or three years of the current program year specified by your local chapter rules?

- What was the violation type as determined by OSHA?
- What was the date of the incident?
- What was the location of the incident?
- Were there any fines, citations or penalties issued? If so, by whom (i.e. OSHA, Police, Department of Transportation, etc.)?
- Who issued the fines, citations or penalties?
- Written Report
- Provide a written report up to five pages that details the following:
 - A full account of the incident and the investigation
 - What corrective actions were taken immediately?
 - What corrective actions were taken culturally?
 - How was accountability addressed?
 - What procedural changes were made?
 - Was there an overall evaluation of the company safety policies, and if so, what changes were made?
 - If the fatality occurred three years prior to this program year, include details as to how your company has implemented the changes discussed above and how it has affected the overall safety performance.

Upload your company's OSHA Form 300A (project specific, if available) for the year(s) the project was under construction. If you are submitting annual logs for the years the project was under construction, you must adhere to the following guidelines:

- Include a year-to-date log if the contract was completed in the current program year.
- The logs must be specific to the office location that completed the work.
- All recordables specific to the project being submitted must be <u>highlighted</u>.
- If the project was under construction for more than one year, you must combine the form files to upload together as one file, arranged in chronological order starting with the most recent year.

Upload your company's OSHA Form 300 (project-specific, if available) for the year(s) the project was under construction.
