Rules and Notes about Voting Rights, Proxy Assignment and the Annual Meeting

Who can attend?

The Annual Meeting, held during Championships, is open to the public. Voting credentials are confirmed/delivered at check-in prior to the meeting. A quorum for the meeting is defined as those members in attendance.

Who can Vote? (NAGVA Bylaws - Article 2.02 - Voting Rights)

- A. Teams and Leagues* shall each be entitled to one vote.
- B. Past Presidents and current Officers shall each be entitled to one vote.
- C. Teams, Leagues, Past Presidents, and current Officers shall constitute the General Membership of this Association.

**Leagues must register annually, using the same process as Team Reps use for registering a team for a season (same fee)*

What is a Proxy? (NAGVA Bylaws - Article 2.02 - Voting Rights)

Any voting member (as defined above) who cannot personally attend the Annual Meeting can use this form to assign his/her written proxy to another member who is in good standing and who has paid their season dues. The Proxy is authorized to attend and vote on the proxy Assignor's behalf.

How many votes can one person have? (NAGVA Bylaws - Article 2.02 - Voting Rights)

A person may cast more than one (1) vote at the Annual Meeting, if credentialed as representing an absent Team, League, or current Officer by authorized proxy. No Member shall proxy for more than 2 teams. No person may cumulate her/his votes.

How do I assign a Proxy?
