Retiring from professional squash a number of years ago I've kept very involved by coaching, MCing, commentating and promoting. I currently coach Christine Nunn and am on the Discipline panel for the PSA. And now, some of you may realise I'm currently Vice President of the World Squash Federation.

I still love to travel and play squash, so my connections with local and regional squash clubs, players and people is still very high.
